Boundaries of the City of Timaru Defined

PURSUANT to section 26 of the Municipal Corporations Act 1954, the Secretary for Local Government hereby redefines, as set out in the Schedule hereto, the boundaries of Timaru City, having previously been altered by Order in Council made on 20 September 1976 and published in the *New Zealand Gazette*, No. 102, 23 September 1976, page 2176.

CITY OF TIMARU

ALL that area in the Canterbury Land District, containing 2342 hectares more or less, bounded by a line commencing at a point on the mean high water mark of the sea in line with the south-western boundary of Lot 1, D.P. 15376, Block XI, Arowhenua Survey District, and proceeding southerly generally along the mean high water mark of the sea to its intersection with the general northern boundary of the parcel marked A on S.O. Plan 13954; thence easterly generally and south-westerly generally along the general northern and south-eastern boundaries of that parcel and the western boundary of the parcel marked D on S.O. Plan 13954 to the southernmost corner of the last-mentioned parcel being a point on the mean high water mark of the sea as described in *New Zealand Gazette*, 1894, page 1526, and as shown on S.O. Plan 11640; thence south-westerly along that mean high water mark to the northernmost corner of the parcel marked B on S.O. Plan 13954; thence south-easterly generally along the general north-eastern boundary of that parcel to its easternmost corner, being a point on the mean high water mark of the sea as described in *New Zealand Gazette*, 1894, page 1526, and as shown on S.O. Plan 11640; thence north-easterly and southerly along that mean high water mark to the north-western boundary of the parcel marked C on S.O. Plan 13954; thence north-easterly generally and southerly generally along the general north-western and general eastern boundaries of that parcel to its southernmost corner being a point on the mean high water mark of the sea; thence southerly generally along that mean high water mark to the southern boundary of Reserve 1856; thence westerly generally along that boundary to the southernmost corner of Lot 2, D.P. 24668; thence north-westerly generally along the south-western boundaries of Lots 2 and 7, D.P. 24668, to the north-western boundary of the said Lot 7; thence north-easterly along that boundary and its production to the left bank of Saltwater Creek; thence north-westerly generally along that bank, crossing King Street, to the north-eastern boundary of Lot 6, D.P. 22702; thence north-westerly along the north-eastern boundaries of Lots 6 and 5, D.P. 22702 to the south-eastern boundary of Lot 2, D.P. 18967; thence south-westerly along that boundary and its production to the left bank of Saltwater Creek; thence north-westerly generally along that bank to the original north-western side of Coonor Road; thence north-easterly generally along that roadside to the western boundary of Lot 1, D.P. 37327; thence northerly along that boundary and its production to the easternmost corner of Lot 1, D.P. 7812; thence north-westerly along the north-eastern boundary of that lot to the left bank of Otupua Creek; thence northerly generally along that bank to the southernmost corner of Lot 18, D.P. 8445; thence north-westerly along a right line to the south-eastern corner of that part of Rural Section 6296 comprised
