

right line across Mathers Road and the southern boundary of Section 1 of the said Block II to the south-western corner of that section; thence southerly along the eastern boundaries of Whiroroa A2 and A6 Blocks and the last-mentioned boundary produced to the middle of Mathers Road; thence westerly along the middle of that road to a point in line with the southern boundary of the said Whiroroa A6 Block; thence westerly to and along that boundary and the southern boundary of Whiroroa A5 Block to the south-western corner of that block; thence southerly along the eastern boundaries of Whiroroa A4 and A7 Blocks and the last-mentioned boundary produced to the middle of Mathers Road; thence south-westerly along the middle of that road to a point in line with the south-western boundary of the said Whiroroa A7 Block; thence generally westerly to and along that boundary, the southern boundaries of Whiroroa A3 Block and Section 5, Block V, Otake Survey District, the south-eastern boundary of Section 7 of the said Block V, a right line across a public road, the south-eastern and generally southern boundaries of Section 6, Block V, the southern boundary of Section 1, Block VIII, Maungamangero Survey District, a right line across Mairoa Road, the generally southern and western boundaries of Lot 2, D.P. 13254, and the southern boundaries of Section 38, 30, 14, 15, and 15A, Block VIII, Maungamangero Survey District, to the south-western corner of the last-mentioned section; thence northerly along the western boundary of the said Section 15A and its production to the middle of Te Kumi Te Anga Road; thence westerly along the middle of that road to a point in line with the western boundary of Section 23, Block VIII, Maungamangero Survey District; thence northerly to and along that boundary and the western boundary of Section 20 of the said Block VIII and its production to the middle of Ngapaenga Road; thence generally north-westerly along the middle of that road to a point in line with the generally southern boundary of Section 23, Block III, Maungamangero Survey District; thence generally westerly to and along the said boundary and the south-western boundaries of that Section to its westernmost corner; thence north-westerly along the southwestern boundary of Section 28 of the said Block III and its production to the middle of the Mangaohae Stream; thence generally northerly along the middle of that Stream to and along the generally western boundary of Te Anga Riding hereinbefore described to the point of commencement.

ALL that area in the South Auckland and Taranaki Land Districts, Waitomo District, containing 401 square kilometres, more or less, commencing at the north-eastern corner of Lot 1, D.P. S. 13101, situated in Block VII, Orahiru Survey District, being a point on the generally north-eastern boundary of the Waitomo District as hereinbefore described and proceeding generally south-easterly along that boundary to the south-eastern corner of part Lot 1, D.P. 35582, in Block V, Ranginui Survey District; thence generally south-westerly along the south-eastern boundary of the said part Lot 1 and the north-eastern, generally north-western and western boundaries of Lot 1, D.P. S. 11156, and the southern boundary of Section 2, Block XII, Pakaumanu Survey District, to the south-western corner of that section; thence generally north-westerly along the western boundary of the said Section 2, a right line across a public road, the south-western boundary of Section 3 of the said Block XII and the last-mentioned boundary produced to the middle of the Okahukura Stream; thence westerly down the middle of that stream to a point in line with the western boundary of Part Tiroa D1 Block; thence generally south-westerly to and along that boundary and the north-western boundaries of Lot 1, D.P. S. 12989 to the southernmost corner of Lot 1, D.P. S. 12750; thence generally westerly along the south-western boundaries of that lot, Part Rangitoto Tuhua 25 Section 5B1 Block, Rangitoto Tuhua 25 Section 5B2 Block and the southern boundaries of Rangitoto Tuhua 35I2B1, 35I2B2 and 35I2C Blocks to the south-western corner of the last-mentioned block; thence southerly, westerly, and generally northerly along the eastern, southern, and generally western boundaries of Lot 1, D.P. 30903 to the north-western corner of that lot; thence westerly along the southern boundaries of Rangitoto Tuhua 35I3B2 Block and part Section 1, Block V, Pakaumanu Survey District, to the south-western corner of that section; thence generally southerly along the western and south-western boundaries of Section 4, Block IX, Pakaumanu Survey District, the north-western boundary of Section 2 of the said Block IX and the last-mentioned boundary produced to the middle of the Moku River; thence westerly down the middle of that river to a point in line with the western boundary of Lot 4, D.P. 5352 (Taranaki Land Registry);

thence southerly to and along that boundary, crossing the Taumarunui-Te Kuiti Road (State Highway 30) and the North Island Main Trunk Railway to the northern boundary of Lot 5, D.P. 5352; thence southerly and easterly along the western and southern boundaries of that lot to the north-easternmost corner of Section 4, Block IV, Mapara Survey District; thence southerly along the eastern boundary of that section and its production to the middle of Kopaki Road; thence south-westerly along the middle of that road to a point in line with the middle of Pukerimu Road; thence generally north-westerly to and along the middle of that road to a point in line with the western boundary of Section 7, Block IV; thence southerly to and along that boundary to the easternmost corner of Lot 1, D.P. 8907 (Taranaki Land Registry); thence generally westerly along the northern boundary of that Lot to the eastern boundary of part Section 3, Block IV, aforesaid; thence southerly, westerly, and north-westerly along the eastern, southern and south-western boundaries of that section to the south-easternmost corner of part Section 2, Block III, Mapara Survey District; thence westerly along the southern boundary of that section to the northernmost corner of Section 7, Block III, aforesaid; thence westerly along the northern boundary of that section and its production to the middle of Mapara Road; thence southerly along the middle of that road to a point in line with the south-western boundary of subsection 1 of Section 3, Block III, aforesaid; thence westerly to and along that boundary crossing the Mapara Stream to a point on the eastern boundary of Part Rangitoto Tuhua 72B2 Block; thence northerly along that boundary, the eastern boundary of Part Rangitoto Tuhua 72B3A Block, crossing Tikitiki Road and the western side of State Highway 4 to the northern boundary of the said Part 72B3A; thence westerly along that boundary to the north-western corner of the said block; thence generally northerly, westerly, and south-westerly along the generally eastern, northern, and north-western boundaries of Lot 2, D.P. 7510 (Taranaki Land Registry) situated in Block III, Mapara Survey District, and the last-mentioned boundary produced to the middle of the Mapara Stream; thence generally westerly down the middle of that stream to a point in line with the western boundary of Section 23, Block V, Totoro Survey District; thence northerly to and along that boundary to the north-eastern corner of Rangitoto Tuhua 57B2D Block; thence westerly along the northern boundaries of that block and Rangitoto Tuhua 57B2C, 57B2B and 57B2A Blocks to the eastern boundary of Section 3 of the said Block V; thence generally northerly along that boundary, the eastern boundaries of Section 10 and part Section 8, Block II, Totoro Survey District, the southern and western boundaries of Section 17 of the said block II and the last-mentioned boundary produced to the middle of Tuhua Road; thence generally westerly along the middle of that road to a point in line with the western boundary of Maraetaua 3B2A Block; thence northerly to and along that boundary, crossing Maraetaua A8B Block and the Mangapehi Stream to and along a right line across the Moku River to and along the western boundary of Maraetaua 3B2B Block and the western boundary of Section 32, Block VI, Otake Survey District, to the north-western corner of that section; thence westerly along the northern boundary of Section 11 of the said Block VI to the south-eastern corner of Section 12, Block VI; thence north-easterly along the south-eastern boundaries of that section and Section 13, part Section 14, Section 15, and part Section 16 of the said Block VI and Karuotewhenua 3D3B2 Block to the north-eastern corner of that block; thence generally northerly along the generally eastern boundary of Mairoa Riding hereinbefore described to the point of commencement.

#### TAINUI RIDING

ALL that area in the South Auckland Land District, Waitomo District, containing 659 square kilometres, more or less, commencing at the intersection in Block III, Whareorino Survey District, of the southern boundary of Kinohaku West G1C2A Block with the sea coast and proceeding generally easterly along the generally southern boundary of Te Anga Riding as hereinbefore described to the intersection in Block IX, Maungamangero Survey District, of the middle of a public road through Section 5 of the said Block IX with the middle of the Awakino River; thence generally southerly down the middle of that river to a point in line with the northern boundary of Section 4, Block II, Awakino East Survey District; thence easterly to and along that boundary to the western side of Mangaorongo Road; thence south-easterly along a right line across that road to and along the north-eastern boundary of Section 1 of the said Block II and that boundary produced to the middle of State Highway 3; thence generally north-easterly along the middle of that highway to a point in line with the northern boundary of Puketiti 2B2E2 Block situated in Block III, Awakino East Survey District; thence easterly to and
