PURSUANT to the Electric Power Boards Act 1925 and the Local Government Act 1974, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. Interpretation—In this order unless the context otherwise requires-

 - "Board" means the Thames Valley Electric Power Board.
 "Council" means the Te Aroha Borough Council.
 "Agreement" means the Agreement for sale and purchase between the Board and the Council dated 12 March
- 2. Merger of District—The licensed area of supply of the Council as defined in the Te Aroha Borough Council Electric Lines Licence 1976 (dated 31 March 1976) and published in the New Zealand Gazette on 29 April 1976, at p. 984, is hereby included and proposed in the New Zealand Gazette on 29 April 1976, at p. 984, is hereby included and merged in the Board's electric power district.
