*Classification of State Highways*

PURSUANT to regulation 3 of the Heavy Motor Vehicle Regulations 1974\*, the Secretary for Transport, as required by the National Roads Board, hereby revokes all warrants and portions of warrants which refer to the classification of the roads described in the First Schedule hereto, and hereby declares that the roads described in the Second Schedule hereto shall belong to the classes as set out in the said Second Schedule.

**STATE HIGHWAYS CLASSIFIED IN CLASS ONE**

*No. 1 State Highway (Awanui-Bluff):*

That portion of the said State highway within Kaitiāra Borough (RP 01/6.02 to RP 01/9.27).

That portion of the said State highway within Hikurangi Town District (RP 144/3.14-RP 144/5.94).

That portion of the said State highway within Whangarei City (RP 158/0.10 to RP 165/3.38).
