Maramarua Survey District, to and south-westerly along the north-western boundary of Allotment 143, Koheroa Parish, and south-easterly along the south-western boundary of the said allotment and that boundary produced to the middle of Orams Road; thence south-westerly along the middle of that road and the public road forming the generally north-eastern and southern boundaries of Allotment 256. Sections 10S and 5S, Mangakura Settlement, to a point in line with the western boundary of Section 13S, Mangakura Settlement; thence southerly along a right line

across a public road to and along that boundary to the southern corner of the aforesaid 13S; thence generally easterly along the south-eastern boundary of the aforesaid section to and along the centre of a public road and Kopuku Road to a point in line with the western boundary of Section 5, Block VI, Piako Survey District, thence along the western boundaries of the aforesaid section to the north-western corner of the said Section 5; thence easterly along a right line across a public road and the southern boundary of part Section 19, Block VI, Piako Survey District; to the south-western boundary of Section 35, Blocks VI and X, Piako Survey District; thence south-westerly, south-easterly, and north-easterly along the southwestern and south-eastern boundaries of that section, to and generally easterly along the general southern boundaries of Section 21, Block VI, to a point in line with the eastern boundary of Section 7, Block VI; thence southerly to and along the eastern boundary of that section; thence easterly and northerly along the southern and eastern boundaries of Section 25, Block VI, to Trig. Station 1531; thence generally south-easterly along the north-eastern boundary of Section 2, and the north-western boundary of Section 2, Block VI, to and along the south-western boundaries of the Section 15, Block XI, Piako Survey District, the abutment of North Road, Section 18, the abutment of South Road, Sections 19 and 5, all the aforesaid sections being of Block XI, Piako Survey District, along the western boundaries of part Section I and Section 2, Block XV, aforesaid a right line across Matahuru Gorge Road to and along the generally western boundaries of Section 9, Block XVI, Piako Survey District, Sections 13S, 14S, part 3S and 12S, Tainui Settlement, Hoe-O-Tainui North, part 6B2J1 and 5B2, Sections 6 and 7, Block VIII, Hapuakohe Survey District, Hoe-O-Tainui North 5A, North 2A2, and 2A1, to the intersection in Block XII, Hapuakohe Survey District, of the production north-easterly of a right line from the easternmost corner of Allotment 639. Taupiri Parish, and passing through the southernmost corner of Allotment 435B of the said parish; thence south-westerly generally along the said right line to the aforesaid easternmost corner and along the south-western side of Proctors Road to the middle of the Mangawhara Stream; thence generally south-westerly down the middle of that stream to its confluence with the Waikato River; thence generally southerly up the middle of the Waikato River to a point in line with the production of the northern boundary of Section 92, Suburbs of Newcastle North, situated in Block VII, Newcastle Survey District; thence generally easterly along the northern boundaries of the aforesaid section and Lot 16, D.P. S. 13937; thence by a right line across the Old Taupiri Road to the south-western corner of Section 96; thence along the south-western boundary of the said Section 96 and that boundary produced across Section 97 to the south-western corner of Section 102, by the south-western boundary of the last-mentioned section to the southern corner; thence by a right line across the North Island Main Trunk Railway to the western corner of Section 149 as shown on S.O. 24652; thence along the northwestern boundaries of the aforesaid Sections 149 and 150 to the northernmost corner of Lot 44, D.P. 7762; thence along the south-western boundaries of Section 151 and Section 158, the boundary of the last-mentioned section produced, across Kent Street, and by the south-western boundaries of Sections 177 and 184, the crossing of Duke Street by the south-western boundary of Section 193 to the southern corner of that section; thence along the north-western boundaries of Sections 201, 202, and 203 to and by River Road forming the south-western boundary of Section 190 to a point in line with the production of the north-western boundary of Section 213, across a public road to that boundary, and by the north-western boundaries of the said Section 213 and Section 222 all being suburbs of Newcastle North, and that boundary produced across the Waikato River; thence by the left bank of the said river in a south-easterly direction to the south-eastern boundary of a ballast reserve; thence along that boundary and the south-eastern boundary of suburban Section South No. 101, across and by a public road forming the north-eastern boundary of Section 118 by a right line across a public road from the northern corner of the last-mentioned section to the eastern corner of Section 111, by the north-eastern boundaries of the last-mentioned section and Section 110, and the last-mentioned boundary produced across a public road to the eastern boundary of Section 109A, all of the Town of Newcastle South; thence southerly along that boundary to the centre of the Waipa River; thence southerly generally up the middle of the Waipa River to a point in line with the northern boundary of Allotment 66B3C3D of the Parish of Waipa; thence westerly generally along a right line, to and along the said northern boundary, crossing intersecting public roads, and along the northern boundaries of Allotments 66B3CF, part 66B3C3C, east part 66B3D1, 66B3B, and west part 66B3D1B of the said Waipa Parish, a right line across a public road, to and along the northern boundary of that portion of Allotment 66B3C3C aforesaid, situated in Block XIV, Whaingaroa
