

## WAIKATO

ALL that area bounded by a line commencing at the south head of the Aotea Harbour and proceeding generally north-easterly along the sea coast to and along the generally southern boundary of Rangiriri Electorate hereinbefore described; to and thence south-easterly along the western boundary of Hauraki Electorate, hereinbefore described, to and along the south-western boundaries of Lots 6 and 5, D.P. 12470, Lot 1, D.P. 29694, Lot 1, D.P. 29321, Lot 1, D.P. S. 3536, Lot 2, D.P. 20628, part Lot 1, D.P. 3622, and Lot 9, D.P. 6948, along a right line across Piako Road, the Rotorua Branch Railway and a public road, to and along the western boundaries of Lots 1 and 2, D.P. 8165, Lot 1, D.P. 7723, a right line across State Highway No. 26, to and along the western and south-western boundaries of Lot 2 and the south-western boundary of Lot 1, both lots being of D.P. S. 2799, along the southern boundary of part Lot 2, D.P. 7860, to and along a series of right lines passing through parts Tahuroa No. 1 as shown on D.P. 23795, parts Tahuroa No. 1, across Tahuroa Road and through Lot 1, D.P. S. 3993, and Lot 2, D.P. S. 3994, being the generally southern boundaries of Lots 1 and 2, L.T. Plan 20705, to the westernmost corner of Lot 5, D.P. 11745; thence south-easterly generally along the western boundaries of the said lot and Lots 4, 3, 2, and 1, D.P. 11745, and that last-named boundary produced to the middle of Scotchmans Valley Road, along the middle of that road to a point in line with the south-western boundary of Lot 2, D.P. 15442, along a right line to and along the said boundary and along the southern boundaries of Section 7, Block XIV, Maungakawa Survey District, Lots 3 and 4, D.P. S. 2306, and part Teauo-waikato No. 8, to and along the western boundaries of Kiwitahi 2E and 2D, and along the southern boundary of the said 2D and its production to and up the middle of the Topengahae Stream to a point in line with the southern boundary of Kiwitahi 1D 1, along a right line, crossing Waterworks Road, to and along the said boundary, to and southerly along the western boundary of Section 5, Block III, Cambridge Survey District; thence south-westerly along the north-western boundaries of part Lot 43, D.P. 14557, part Lot 1, D.P. 2756, crossing the intervening public road, Lots 1 and 2, D.P. 22079, a right line across Whitehall Road, to and along the north-western boundaries of Lot 1, D.P. S. 2875, part Sections E2 and W2, Whitehall Settlement, and that last-named boundary produced across a public road to and along the north-western, and the western boundaries of part Hinuera No. 2, the north-western boundary of Section 15, Karapiro Settlement, to and along the eastern boundary of part Lot 2, D.P. 3569, a right line across French Pass Road to and along the western boundary of part Section 9, Karapiro Settlement, and that last-named boundary produced to the middle of the Karapiro Stream in Block X, Cambridge Survey District; thence westerly down the middle of that stream to the north-western corner of Lot 2, D.P. 14436; thence northerly along the eastern boundary of Allotment 38, Cambridge East Town Belt, a right line across Thornton Road, the eastern boundaries of Allotments 37, 36, 35, 34, and 33, all of the Cambridge East Town Belt to the north-eastern corner of the last-named allotment; thence westerly along the northern boundaries of Allotments 33, 32, 31, 30, and 29, a right line across Watkins Road, the northern boundaries of Allotments 28, 27, 26, and 25, a right line across Swaynes Road, the northern boundaries of Allotments 24, 23, 22, 21, 20, 19, 18, 18A, a right line across Victoria Avenue, the Cambridge Branch Railway, and again Victoria Avenue, the northern boundaries of Allotments 17A, Part 17 and 96, all the aforementioned Allotments being of the Cambridge East Town Belt, and a right line across Hannons Road to its western side; thence southerly along that side and the western boundaries of part Allotments 16 and 15, Allotments 14, 13, 12, 11, 10, 9, 8, 7, and 7A, a right line across State Highway No. 1, the western boundaries of part Allotments 6 and 5, and Allotments 4, 3, and 2, and the western end of a closed road, the western boundary of Allotment 1, all the aforementioned allotments being of the Cambridge East Town Belt and the production of the last-mentioned boundary to the middle of the Waikato River; thence generally north-westerly down the middle of that River to its confluence with Mystery Creek; thence up the middle of Mystery Creek to the southern side of the public road forming the northern boundary of Lot 1, D.P. 29091, in Block VII, Hamilton Survey District, along that roadside to and along the eastern boundaries of Allotments 172 and 173, Te Rapa Parish, and along the southern boundaries of the said Allotment 173, the abutment of a public road, Allotments 171, part 170, and another part Allotment 170, as shown on D.P. 3764, and that last-named boundary produced to the middle of National State Highway No. 3; thence southerly along the middle of that highway and the middle of a stopped road now known as Allotments 399, 400, 398, and 397, all the said allotments being of Te Rapa Parish, to a point in line with the northern side of Douch Road; thence westerly along that roadside, and along the northern side of the public road forming the southern boundary of part Allotment

366, Te Rapa Parish, as shown on D.P. 4391, in Block X, Hamilton Survey District, to a point in line with the eastern boundary of Lot 1, D.P. 24355; thence southerly along a right line across the said road to and along the said boundary and along the eastern and southern boundaries of Lot 2, D.P. 24355, to the eastern side of the public road forming the western boundary of that lot; thence westerly along a right line across that road to and along the northern boundary of Lot 10, D.P. 7308, to and along the southern boundary of the Tuhikaramea Parish, passing through Lot 1, D.P. 23243, Lots 6, 5, and 4, D.P. 6617, and Lot 2, D.P. 14478, and that parish boundary produced to the middle of the Mangaotama Stream; thence down the middle of that stream to the middle of the Waipa River; thence southerly generally up the middle of the Waipa River, to a point in line with the southern boundary of Lot 4, D.P. 24766; thence westerly generally along the southern boundary of Lot 4 aforesaid, and a right line across a public road to and along the southern boundary of Lot 3, D.P. 24766 aforesaid to the eastern boundary of Allotment 41; thence westerly generally along the eastern and southern boundaries of Allotment 41 aforesaid, along the southern boundaries generally of Allotments 43, 44, 45, 46, 47, 350, 349, 348, 347, 346, 345, and the south-eastern and south-western boundaries of Allotment 344 to and along the south-eastern side of a public road forming the north-western boundaries of Allotments 361, part 355, 360, 359, 427, and 369, all the aforesaid, allotments being of Pirongia Parish, to Trig. Station 1922, Mahaukura, situated in Block III, Pirongia Survey District; thence westerly generally along the south-western boundary of Allotment 358, Pirongia Parish, the end of a public road, the south-western boundaries of Allotments 352 and 428, Pirongia Parish aforesaid, and the end of another public road to Trig. Station, Tahuaniu; thence along the south-eastern, southern and western boundaries of part Moerangi No. 4, Block (State forest, *Gazette*, 1948, page 1341), and along the southern boundary of Section 6, Block I, Pirongia Survey District, to its south-western corner, along a right line across Section 9, Block I, aforesaid, to an angle opposite its western boundary and along that western boundary to and along the southern and western boundaries of Section 7, Block I, of the said survey district, along the southern boundary of Section 4, Block IV, Kawhia North Survey District, and a right line from its south-western corner across Kopunui Road, to the nearest road angle on the eastern boundary of Section 18 of the said Block IV; thence along the western side of that road, to and along the southern boundaries generally of Section 8 and Lot 2 of Section 7, Block XV, Karioi Survey District, to and along the eastern boundary of Section 1, Block III, Karioi North Survey District, along the southern boundary generally of Section 2, Block III, aforesaid, along the southern and south-western boundaries of part Moerangi No. 3D 2 Block, along a right line across a public road to and along the south-western boundary of part Moerangi No. 3D 2 Block aforesaid, and along the southern boundary of Moerangi No. 3D 1 Block, to the shores of the Aotea Harbour; thence along the south-eastern and southern shores of that harbour to the point of commencement; excluding therefrom the Hamilton West and Hamilton East Electorates hereinbefore described.

## MATAMATA

ALL that area bounded by a line commencing at the north-western corner of Lot 6, D.P. 12470, situated in Block IV, Komakorau Survey District, being a point on the generally southern boundary of Hauraki Electorate as hereinbefore described; and proceeding generally easterly along that boundary to a point due west of Trig. Station 567, Te Aroha, at the westernmost corner of Katikati Survey District; thence due east to that trig station; thence north-easterly along the north-western boundary of Katikati Survey District to the north-eastern boundary of the original Aroha Block, shown on M.L. 3062; thence south-easterly along that boundary through State forest in Blocks XI and VII, Katikati Survey District, and Block X, Aongatete Survey District, to the northernmost corner of Lot 5, D.P. 25781; thence southerly generally along the eastern boundary of that lot, the eastern side of a public road, the generally eastern boundaries of part Section 20, Block III, Wairere Survey District (State forest, *Gazette*, 1955, page 1892), another part of Section 20 (D.P. 26605) and another part of Section 20 (D.P. 4110), along a right line across Thompsons Track to and south-easterly generally along the generally north-eastern boundaries of another part Section 20, aforesaid (D.P. 28359), Waiharakeke East 1C1A, 1C2B2, 1A, and part 5, and Maurihiro B and A to the south-eastern boundary of Maurihiro A; thence south-easterly along the north-eastern boundary of part Okauia 1 to Trig. Station 909, Waianuanu, at the easternmost corner of Block XVI, Wairere Survey District; thence south-westerly along a right line to Trig. Station 146, Te Weraiti, at the westernmost corner of Block IV, Opoutihi Survey District; thence south-easterly along a
