Rotorua

ALL that area bounded by a line commencing on the western shore of Lake Rotorua and being the easternmost corner of Kawaha 3G in Block XIII, Rotoiti Survey District, and proceeding south-easterly generally along the said shore to a point in line with the south-eastern boundary of Tahererauti 2 (Ohinemutu Pa); thence along that last-mentioned boundary produced for a distance of 14.37 metres bearing 46° 01' 40"; thence south-easterly along a right line bearing 115° 49' 30" to the lake shore aforementioned; thence easterly, south-easterly, and southerly generally along the shore of the said lake to the left bank of the Puarenga Stream; thence southwesterly generally along that left bank to the southernmost corner of Nelson Street; thence along a right line to and along the generally western boundary of Section 6. S. 11880, to and along the right bank of the Utuhina Stream to the middle of Pukehangi Road; thence north-westerly along the middle of that road to a point in line with the middle of Clayton Road; thence north-easterly to and along the middle of that road to a point in line with the middle of Mountain Road; thence to and north-easterly generally along the middle of that road to a point in line with the western boundary of Lot 2, D.P. S. 7118; thence northerly generally to and along that boundary, the western boundary of Lot 1, D.P. S. 7118, the south-western boundaries of Lots 1, 5, 6, and 9, D.P. S. 4068, and the north-western boundary of the last-named lot produced to the middle of Mountain Road; thence north-easterly generally along the middle of that road to a point in line with the generally southeastern boundary of Rotohokahoka D North 4D; thence to and along that boundary to the western side of State Highway No. 5; thence north-westerly along that roadside to a point in line with the south-eastern boundary of Kawaha 3L1; thence to and along that boundary and its production to the middle of the Rotorua Branch Railway; thence south-easterly along the middle of that railway to a point in line with the south-eastern boundary of Kawaha 3H 2; thence north-easterly to and along that boundary to and along the south-eastern boundary of Kawaha 3G to the point of commencement.

S. 7761 situated in Block IV, Rangitaiki Upper Survey District; thence generally easterly to and along the said boundary and north-westerly boundary of Section 8S, Orini Settlement, and its production to the middle of Western Drain; thence generally south-westerly along the middle of that drain to the middle of McLean Road, thence south-easterly along the middle of that road to its intersection with the middle of Western Drain Road; thence south-westerly along the middle of that road to a point in line with the north-eastern boundary of Lot 1, D.P. 18069; situated in Block VII. Rangitaiki Upper Survey District; thence southeasterly and south-westerly to and along the north-eastern and south-eastern boundaries

of the said lot, thence south-easterly along the south-western boundary of part Lot 3. D.P. 18069; and the last-mentioned boundary produced to the middle of State Highway No. 30; thence south-westerly along the middle of that State highway to a point in line with the south-western boundaries of part Allotment 11 and Allotments 11C and 89A, Parish of Rangitaiki; thence south-easterly to and along the said boundaries to the southernmost corner of the said Allotment 89A, thence southerly along a right line, crossing Omataroa Rangitaiki 1 Block, to the north-western corner of Allotment 33L, Rangitaiki Parish; thence generally southerly along the north-eastern and southern boundaries of the said Omataroa Rangitaiki 1 Block to the north-eastern corner of Section 2. Block IV, Rangitaiki Lower Survey District; thence generally southerly along the south-eastern boundary of Section 2 and its production across a public road, part Section 3, Tuararagnaia Part 1B, the southern boundaries of Ruatoki C48 and part 2A, and the western boundary of part Urewera A Block to the south-eastern corner of Oputea Block in Block III, Galatea Survey District; thence southerly along right lines to Trig. Station 2121, Hikurangi, in Block VII, Galatea Survey District, and the north-eastern corner of Section 1, Block II, Ahikereru Survey District; thence generally southerly along the eastern boundaries of that section and Section 5, Block VI, Ahikereru Survey District, the generally northern, generally western, and generally southern boundaries of Section 1, Block XI, Ahikereru Survey District, and the western boundaries of Blocks XI and XV, Ahikereru Survey District, and Block III, Tuawatawata Survey District, thence generally westerly and southerly to and along the generally southern watershed of the Whirinaki River; thence westerly along a right line to Trig. Station B, Pukeroa, in Block XI, Heruiwi Survey District; thence northerly along a right line to Trig. Station F, Tiritiri, in Block III, Heruiwi Survey District, along a right line to Trig. Station 76, Taupiri, in Block XII, Wheao Survey District, along a right line towards Trig. Station 78A, Pekepeke, in Block III, Wheao Survey District, to a point that intersects the middle line of the Rangitaiki River with the said right line, thence generally westerly up the middle of that river to a point in line with the northern boundary of part Kaingaroa 2 Block; thence westerly and southerly to and along the northern and western boundaries of that block to the south-eastern corner of Lot 2, D.P. 30838, in Block VII, Takapau Survey District; thence easterly along the southern boundary of that lot, a right line across Broadlands Road to and along the southern boundary of part Lot 5, D.P. 26766, and the last-mentioned boundary produced to the middle of the Waikato River; thence north-westerly generally down the middle of that river to a point in line with the middle of the Whangapoa Stream in Block VI, Atiamuri Survey District; thence northerly generally to and up the middle of that stream to a point in line with the middle of the stream forming part of the north-eastern boundary of part Section 12, Block III, Atiamuri Survey District; thence to and up the middle of that stream to and westerly along the southern side of State Highway No. 30 to a point in line with the western boundary of Lot 1, D.P. 20272; thence to and along that boundary and the eastern boundary of Lot 1, D.P. 25102, to the south-eastern boundary of part Tokoroa 2; thence north-easterly along that boundary and the south-eastern boundary of Lot 1, D.P. 20031, to the southwestern boundary of Patetere South 1B 3; thence north-westerly along that boundary and its production to and along the south-western boundary of Lot 1, D.P. S. 9825, in Block V, Horohoro Survey District, to the westernmost corner of that lot; thence northeasterly along a right line between that westernmost corner and Trig. Station 27, Puwhenua, at the easternmost corner of Block VII, Tapapa East Survey District, thence generally northerly to and along the right line to a point that intersects the north-eastern boundary of Taumata Block No. 3A1B with the aforesaid right line; thence generally north-easterly along the generally south-eastern boundaries of Kaimai Electorate hereinbefore described, to the point of commencement; excluding therefrom Rotorua Electorate as hereinbefore described.

Taupo

ALL that area bounded by a line commencing at the intersection of the middle of Tihoi Mill Road and the northern boundary of Waihaha 3E3 Block in Block IX, Marotiri Survey District, being a point on the generally eastern boundary of Waipa Electorate hereinbefore described; and proceeding generally northerly along that electorate boundary to and generally easterly along the generally southern boundary of Matamata Electorate hereinbefore described; to the generally western boundary of Tarawera Electorate hereinbefore described; thence generally south-casterly along that boundary and the generally southern boundary of the said electorate to Trig. Te Awamutu in Block XVI, Heruiwi Survey District, then generally southerly along the Whirinaki and Te Hoe Rivers' watershed to Trig. VII in Block IV, Runanga
