Station C, Kopaatuaki, in Block XI, Waimata Survey District; thence generally south-westerly along the south-eastern boundaries of Ngakoroa E and D Blocks, the south-eastern boundary of Lot 4, D.P. 5474 to its intersection with part Waihirere U Block, along the north-eastern and south-eastern boundaries of Waihirere U Block, to the most northerly point of Lot 1, D.P. 3883; thence generally southwesterly along the eastern and south-eastern boundaries of the said Lot 1, D.P. 3883, the south-eastern boundary of Lot 1, D.P. 3639, the north-eastern and southeastern boundaries of Lot 2, D.P. 2269, and its production to the middle of the Gisborne-Ormond via Waiohika Road; thence south-easterly along the middle of that road to its intersection with the middle of the Waimata Valley Road; thence north-easterly up the middle of the said road to a point in line with the northern boundary of Lot 1, D.P. 2222; thence generally south-easterly along the northern and eastern boundaries of Lot 1, D.P. 2222, the eastern boundaries of part Lot 2 and Lot 3, D.P. 1662, the north-eastern boundaries of Lot 1, D.P. 2268, Lots 9 and part Lot 8, D.P. 2969, to the easternmost corner of the said part Lot 8; thence generally north-easterly along a right line to the easternmost corner of Section 6, Block XIV, Waimata Survey District, along another right line to Trig.
