

generally southerly up the middle of the Marua River to a point in line with the northern side of Boundary Road; thence easterly to and along the northern side of that road to the western boundary of Section 21, Block XVI, Burnett Survey District; thence southerly along the western boundary of that section, and southerly and easterly along the western and southern boundaries of Section 22, Block XVI, Burnett Survey District to the southern boundary of Block XIII, Matakaitaki Survey District; thence easterly along that boundary to the summit of the eastern watershed of the Marua River; thence generally south-easterly along that watershed to the summit of the Southern Alps; thence generally south-westerly along that summit to Mount Aspiring; thence north-westerly along a right line to the northernmost corner of Martins Bay Survey District, being a point on the mean high-water mark of the sea; thence generally north-easterly along that mean high-water mark of the sea to the point of commencement.

TASMAN

ALL that piece lying above mean high-water mark within an area bounded by a line commencing at Pukerau Point in Block IV, Whangamoia Survey District, and proceeding due north along a right line to the parallel of latitude 40° 30' south; thence due east along that parallel of latitude to its intersection with meridian of longitude 174° 30' east; thence south-westerly along a right line to a point in Block XXVI, Gore Survey District, bearing 45° true distant 3.2 kilometres from Harding Point; thence due south for 5 kilometres; thence generally south-westerly, southerly, and westerly along the middle of the Pelorus Sound to a point due north of Cullens Point in Block VIII, Wakamarina Survey District; thence due south to Cullens Point; thence generally south-easterly along the eastern watershed of Havelock Harbour and the Kaituna River to Trig. Station MM, Mount Cullen, in Block XIII, Linkwater Survey District; thence generally southerly along the said watershed to Trig. Station GG in Block I, Cloudy Bay Survey District; thence westerly along a right line to the source of Rocky Creek and down the middle line of that creek and its production to the middle of the Kaituna River; thence generally northerly along the middle line of the Kaituna River to a point in line with the middle line of Atahaua Creek; thence generally westerly to and westerly and south-westerly up the middle line of the said creek, following the southern branch, to its source; thence southerly along a right line to Trig. Station Mount Sunday in Block VI, Onamalutu Survey District; thence generally westerly and south-westerly along the summit of the Richmond Range to Wards Pass; thence south-westerly along a right line to Trig. Station Top 2 in Block XV, Motupiko Survey District; thence south-easterly along the north-eastern boundary of Section 3, Square 34, and that boundary produced across No. 63 Provincial State Highway to its southern side; thence south-westerly along the southern side of the aforesaid No. 63 Provincial State Highway to the westernmost corner of Section 6, Square 34; thence easterly along the northern side of a public road to the south-western boundary of the aforesaid Section 6; thence south-easterly along the south-western boundary of the aforesaid Section 6 to the south-eastern corner of Section 11, Block XIV, Motupiko Survey District; thence generally south-westerly along the south-eastern boundary of the aforesaid Section 11 to and along the summit of the St. Arnaud Range to Belvedere Peak; thence generally westerly and south-westerly along the summit of the Spenser Mountains to a point approximately 1 kilometre south-west of Gloriana Peak, being the junction of the said Spenser Mountains with the watershed between the Glenroy River and the tributaries of the Marua River; thence generally north-westerly, north-easterly, and again north-westerly along the eastern boundary of the West Coast Electoral District hereinbefore described to the middle of the mouth of the Kahurangi River; thence generally north-easterly, south-easterly, and again north-easterly along the mean high-water mark of the sea-coast, crossing the mouths of all harbours and inlets to the point of commencement, including all adjacent islands and excluding the Nelson Electoral District, hereinafter described.

ALL that piece bounded by a line commencing at a point at low-water mark upon the seaward side of the Boulder Bank, in line with the north-eastern boundary of part Section 16, District of Suburban North, being the land comprised in certificate of title 3C/359 and proceeding thence in a south-easterly direction by a right line to and along the north-eastern boundary of the aforesaid part Section 16, District of Suburban North, to the north-western side of No. 6 State Highway; thence again south-easterly by a right

line across No. 6 State Highway to the northern corner of part Section 16, District of Suburban North, as shown on D.P. 3360; thence again south-easterly along the north-eastern boundary of the aforesaid part Section 16, District of Suburban North, shown on D.P. 3360, the north-eastern boundaries of Lots 13, 14, 15, 16, and 17, D.P. 6881, and the last-mentioned boundary produced across a street to and along the north-eastern boundary of the aforesaid part Section 16, District of Suburban North, being the land comprised in certificate of title 3C/359, to its easternmost corner; thence south-westerly along the south-eastern boundaries of Sections 16, 15, and 14, District of Suburban North, and the last-mentioned boundary produced to the north-eastern boundary of Section 12, District of Suburban North; thence south-easterly along the north-eastern boundary of the aforesaid Section 12, District of Suburban North, to its easternmost point; thence generally south-westerly along the north-western boundaries of part Sections 12 and 11, District of Suburban North, being the land comprised in certificate of title 3B/1365, to the north-eastern side of Dodson Valley Road; thence south-easterly and south-westerly along the north-eastern side and south-eastern end of the aforesaid Dodson Valley Road to the easternmost corner of Section 18, District of Suburban North; thence south-westerly along the south-eastern boundary of the aforesaid Section 18, District of Suburban North, to its southernmost point; again south-westerly by a right line to the southernmost corner of Section 8, District of Suburban North; thence north-westerly along the south-western boundary of the aforesaid Section 8, District of Suburban North, to a point in line with the south-eastern boundary of part Section 4, District of Suburban North (3 acres 1 rood 8 perches), as shown on D.P. 1618; thence south-westerly to and along that boundary, the north-western boundary of Lot 1, D.P. 5647, and the south-eastern boundary of part Section 4, District of Suburban North, as shown on L.T. Plan 362/C2 to the southernmost corner of the aforesaid part Section 4, District of Suburban North, again south-westerly by a right line to the easternmost corner of Section 1, District of Suburban North; thence south-westerly along the south-eastern boundary of the aforesaid Section 1, District of Suburban North, to the southernmost corner of Lot 3, D.P. 3202, being a point on the north-western boundary of Section 60, Block IX, Wakapuaka Survey District; thence south-westerly along the north-western boundaries of the aforesaid Section 60 and Section 59, Block IX, Wakapuaka Survey District, to the north-western corner of Section 58, Block IX, aforesaid; thence generally southerly, easterly and northerly along the western southern, and eastern boundaries of the aforesaid Section 58 to the south-western corner of the aforesaid Section 59, Block IX, Wakapuaka Survey District; thence easterly, northerly, and again easterly along the southern and eastern boundaries of the aforesaid Section 59 to the westernmost corner of Section 11, District of Brook Street and Maitai; thence south-easterly along the south-western boundary of the aforesaid Section 11 and that boundary produced to the left bank of the Maitai River; thence generally northerly, southerly, and westerly along the left bank of that river to the north-western corner of Section 37, Block IX, Wakapuaka Survey District; thence southerly along the western boundary of the aforesaid Section 37 to the northern boundary of Section 7, Block B, District of Wakatu; thence southerly, easterly, and again southerly along the eastern, northern, and other eastern boundaries of the aforesaid Section 7 and the last-mentioned boundary produced to the north-eastern corner of Section 8, Block B, District of Wakatu, along the eastern boundaries of the aforesaid Section 8 and Sections 9 and 10, Block B, District of Wakatu; thence south-westerly along the south-eastern boundaries of the aforesaid Section 10 and Section 11, Block B, District of Wakatu, the last-mentioned boundary produced across a road to the easternmost corner of Section 19, Block B, District of Wakatu, and along the south-eastern boundaries of the aforesaid Section 19 and Sections 20 and 21, Block B, District of Wakatu, to the northernmost corner of Section 1, District of Brook Street and Maitai; thence generally south-easterly along the north-eastern boundary of the aforesaid Section 1, the north-eastern boundaries of part Section 36, Section 44, and other parts Section 36, District of Brook Street and Maitai, to the easternmost corner of the aforesaid Section 36; thence south-westerly along the south-eastern boundary of the aforesaid Section 36 to the north-eastern boundary of Section 35, District of Brook Street and Maitai, along the north-eastern and south-eastern boundaries of the aforesaid Section 35, the south-eastern boundary of Rural Section 1, District of Brook Street and Maitai, and the last-mentioned boundary produced through Sections 22 and 14, Square 18, to its intersection with the production of the south-western boundary of Section 3 of 8, District of Brook Street and Maitai; thence north-westerly to and along the south-western boundary of the aforesaid Section 3 of 8 to its westernmost corner; thence north-easterly along the north-western boundaries of the aforesaid Section 3 of 8 and Sections 10, 8, and 7, District of Brook Street and Maitai, to the south-western boundary of Section 29, Block D, District of Wakatu; thence north-westerly along the south-western boundaries of the aforesaid Section 29 and
