PAPANUI

ALL that piece, bounded by a line commencing at the intersection of the middle lines of the old bed of the Waimakariri River and Dickey's Road, being a point on the southern boundary of the Electoral District of Rangiora, hereinbefore described, and proceeding south-easterly generally along the south-western boundary of that district to its intersection with the middle line of Prestons Road; thence westerly and southerly along the middle lines of that Road and Grimseys Road to the middle of Winters Road; thence westerly along that middle line to a point in line with the south-eastern boundary of Lot 1, D.P. 16400; thence south-westerly to and along that boundary, across Cranford Street (No. 1 State Highway) and continuing along the south-eastern boundaries of Lot 2, D.P. 25100, Lot 1, D.P. 7419, and the abutment of Grassmere Street to the south-western boundary of Lot 2, D.P. 6313; thence south-easterly along that boundary and the south-western boundary of the Part Lot 6, D.P. 14182, comprised in C.T. 494/208 and its production to the intersection of the middle lines of Tomes Road and Rutland Street; thence south-easterly along the middle of Rutland Street to the middle of Mays Road; thence westerly generally along the middle lines of Mays Road, Papanui Road, Blighs Road, Wairakei Road and Ilam Road to the middle of Brookside Terrace; thence north-westerly along the middle of that terrace to a point in line with the south-eastern boundary of Lot 75, D.P. 15693; thence south-westerly to and along that boundary to the southernmost corner of that lot; thence north-westerly generally along the south-western boundaries of Lots 75 to 72 inclusive, D.P. 15693, to a point in line with the south-western boundary of Lot 71, D.P. 15693, to and along that boundary and the north-western boundary of that lot to a point in line with the south-western boundary of Lot 69, D.P. 15693, to and along the south-western boundaries of Lots 69 to 56 inclusive, D.P. 15693, along the south-eastern boundaries of Lots 239 and 240, D.P. 19549, and the north-eastern boundary of the last-mentioned lot to its northernmost corner; thence south-westerly generally across Hooker Avenue along a right line to the southernmost corner of Lot 55, D.P. 15693, along the south-western boundary of that lot, the south-eastern boundaries of Lots 10 and 9, D.P. 17030, the south-western boundaries of Lots 9 and 8, D.P. 17030, and Lot 2, D.P. 26143, the western boundaries of part Lot 1, D.P. 17030, comprised in C.T. 8B/697 and Lot 1, D.P. 22779, and the south-western side of Brookside Terrace to the easternmost corner of Lot 1, D.P. 15693; thence southerly along the eastern boundaries of Lots 1, 2, and 3, D.P. 15693, and north-westerly along the south-western boundary of the last-mentioned lot and its production to the middle of Greers Road; thence north-easterly along the middle of that road to the middle of Wairakei Road; thence north-westerly along the middle of that road to the middle of Russley Road; thence northerly along the middle of that road to the middle of Harewood Road; thence westerly and northerly along the middle lines of Harewood Road and McArthur's Road and the production of the last-mentioned middle line to the southern boundary of the Electoral District of Rangiora hereinbefore described; thence easterly along that boundary to the point of commencement.

ST. ALBANS

ALL that piece, bounded by a line commencing at the intersection of the middle lines of Burwood Road and Mairehau Road, being a point on the southern boundary of the Electoral District of Rangiora, hereinbefore described; and proceeding southerly along the middle of Burwood Road, Lake Terrace Road, and the production of the last-mentioned middle line to the middle of the Avon River; thence up the middle of that river (through Kerrs Reach) and Dudley Creek to a point in line with the middle of Averill Street; thence south-westerly generally to and along the middle of Averill Street, Stapletons Road, Stanmore Road, Avalon Street, Perth Street, London Street, and Bealey Avenue to the middle of Geraldine Street; thence northerly along the middle of Geraldine Street and westerly generally along the middle of Purchas Street, Caledonian Road, Durham Street, and Clare Road to the middle of Papanui Road;

thence north-westerly along the middle of that road to the generally southern boundary of the Electoral District of Papanui, hereinbefore described; thence easterly generally along that boundary and the generally south-western boundary of the Electoral District of Rangiora, hereinbefore described; to the point of commencement.

CHRISTCHURCH CENTRAL

ALL that piece, bounded by a line commencing at the intersection of the middle lines of Deans Avenue and Moorhouse Avenue and proceeding easterly along the middle of Moorhouse Avenue and southerly along the middle of Waltham Road to the middle of the Lyttelton-Bluff Railway; thence south-easterly along the middle of that railway to the middle of Ensors Road; thence north-easterly generally along the middle of that road, Ferry Road, St. Johns Street, and Linwood Avenue to a point in line with the western boundary of Lot 1, D.P. 8825 (Bromley Cemetery); thence northerly to and along that boundary and its production to the middle of Keighleys Road; thence northerly generally along the middle of that road and McGregors Road to a point in line with the south-western boundary of part Lot 1, D.P. 8756, comprised in C.T. 414/6 (Linwood Cemetery); thence north-westerly to and along that boundary and its production to the middle of Butterfield Avenue; thence northerly generally along the middle of that avenue, Buckleys Road, Kerrs Road, and the production of the last-mentioned road to the southern boundary of the Electoral District of St. Albans, hereinbefore described; thence westerly generally along that boundary to the middle of Papanui Road; thence south-westerly generally along the middle of that road and Bealey Avenue to the middle of the Avon River; thence up the middle of that river to a point in line with the middle of Deans Avenue; thence southerly to and along the middle of that avenue to the point of commencement.

AVON

ALL that piece, bounded by a line commencing at the mean high-water mark of the sea, being a point on the southern boundary of the Electoral District of Rangiora, hereinbefore described, and proceeding south-easterly generally along the mean high-water mark of the sea, crossing the estuary of the Avon and Heathcote Rivers to the point at Cave Rock; thence north-westerly generally along the south-western shore of the said estuary to a point in line with the middle of Linwood Avenue; thence north-westerly to and along the middle of that Avenue to the eastern boundary of the Electoral District of Christchurch Central, hereinbefore described; thence northerly generally along that boundary and the eastern boundary of the Electoral District of St. Albans, hereinbefore described, to the southern boundary of the Electoral District of Rangiora hereinbefore described; thence easterly generally along that boundary to the point of commencement.

SYDENHAM

ALL that piece, bounded by a line commencing at the intersection of the middle lines of Ensors Road and the Lyttelton-Bluff Railway, being a point on the southern boundary of the Electoral District of Christchurch Central, hereinbefore described; and proceeding south-westerly along the middle of Ensors Road and its production to the middle of the Heathcote River; thence south-westerly generally up the middle of that river and Cashmere Stream to a point in line with the eastern boundary of Lot 4, D.P. 23758; thence north-westerly to and along that boundary, along a right line across Cashmere Road to the easternmost corner of part Lot 22, D.P. 3217 comprised in C.T. 282/285, along the north-eastern boundaries of that part lot, part Lot 15, D.P. 3217 comprised in C.T. 11B/358 and Lots 1 and 2, D.P. 20481, and the production of the last-mentioned boundary to the middle of Sparks Road; thence south-westerly along the middle of Sparks Road, and north-westerly along the middle of Hendersons Road to the middle of Halswell Road; thence north-easterly along the middle of Halswell Road to its intersection with the middle of Annex Road; thence south-easterly along the production of the middle line of Annex Road to the south-eastern side of Lincoln Road; thence north-easterly generally along that roadside to the production of the north-eastern side of Wrights Road, along that production to the middle of Lincoln Road and along the middle of Lincoln Road to a point in line with the south-western boundary of Lot 3, D.P. 12877; thence north-westerly to and along the south-western
