

S C H E D U L E
DESCRIPTIONS OF THE BOUNDARIES OF THE ELECTORAL
DISTRICTS

BAY OF ISLANDS

ALL that area bounded by a line commencing at the middle of the mouth of the southern branch of the Waipoua River in Block V, Waipoua Survey District; and proceeding north-westerly and easterly generally, along the middle of the Waipoua River to its intersection with the western boundary of Block VIII, Waipoua Survey District; thence northerly along the western boundaries of Blocks VIII and IV, Waipoua Survey District, and easterly along the northern boundaries of Block IV, Waipoua Survey District, and Block I, Tutamoe Survey District, to and along the north-western boundaries of Section 16, Block I, Tutamoe Survey District, and that last boundary produced to the middle of the Mangakahia River in Block XIII, Punakitere Survey District; thence easterly generally along the middle of the Mangakahia River to a point in line with the western boundary of Section 3, Block XV, Punakitere Survey District; thence northerly along a right line to and along the western boundary of Section 3, crossing the public road which intersects that Section 3, and along the generally northern boundary of Section 3 and the production of the last-mentioned boundary to the middle of the Mangaraupo Stream; thence easterly down the middle of the Mangaraupo Stream and again down the middle of the Mangakahia River to a point in line with the north-eastern boundary of Aukumeroa No. 2 Block in Block IV, Tutamoe Survey District; thence south-easterly along the north-eastern boundary of Aukumeroa No. 2 Block and the production of that boundary to the middle of the Mangakahia River; thence easterly down the middle of that river to and northerly up the middle of the Awarua River to a point in line with the southern boundary of part Nukutawhiti Block shown on D.P. 9193; thence easterly along a right line across a public road, and along the southern boundary of part Nukutawhiti Block, parts of which now form the southern boundaries of Lots 1, 2, 3, 4, 5, and 6, D.P. 11394, to its junction with the western boundary of Lot 4, D.P. 27693, in Block I, Mangakahia Survey District; thence south-easterly generally along the north-eastern boundaries of Nukutawhiti Block to and easterly along the northern boundary of Kaikou No. 4 Block 1 and south-easterly along the north-eastern boundary of Lot 1, D.P. 22383, and the south-western boundaries of Lot 2, D.P. 22383, and north-easterly and south-easterly along the north-western and north-eastern boundaries of Section 1, Block VI, Mangakahia Survey District, and south-easterly along the north-eastern boundary of Lot 4, D.P. 42339, and southerly along the eastern boundary of Section 5, Block VI, Mangakahia Survey District, to its junction with the southern boundary of Pipiwai No. 2H20 Block; thence easterly along the southern boundaries of Pipiwai No. 2H20, 2H19, 2H23, and 2H9 Blocks to and northerly along the right bank of the Hikorangi River, to a point in line with the northern boundary of Section 2, Block VII, Mangakahia Survey District; thence easterly along a right line to and along that boundary crossing the intervening Pipiwai Titoki Road to the easternmost corner of that Section 2, thence along a right line to the intersection of a right line between the southernmost corner of Section 4, Block VIII, Mangakahia Survey District, and the northernmost corner of Waitomotomo 3B Block and another right line between the easternmost corner of Section 28, Block VIII, Mangakahia Survey District, and the southern end of the western boundary of Section 20, Block II, Purua Survey District; thence south-easterly along the last-mentioned right line and its production to the middle of the Wairua River; thence south-easterly generally down the middle of the Wairua River to and easterly up the middle of the Mangere River to and up the middle of the Patuwairua Stream to a point in line with the north-eastern boundary of Allotment 20, Kaitara Parish, in Block VI, Purua Survey District; thence south-easterly along a right line to and along the north-eastern boundaries of Allotments 20 and 22, Kaitara Parish, Lot A, D.P. 489, along a right line across Gray Road to and along the north-western boundary of Lot B, D.P. 489, and along a right line to the south-western corner of Lot 1, D.P. 68759, in Block XI, Purua Survey District; thence easterly along a right line to the westernmost corner of Allotment NW 55, Whangarei Parish, in Block XII, Purua Survey District, to and south-easterly along the north-eastern boundaries of Allotment 8, Pukenui Parish, and along the south-western end of a public road, and along the south-western boundary of Allotment 73, Whangarei Parish, and along the south-western end of a public road to the south-westernmost corner of Allotment S77, Whangarei Parish, and easterly along the southern boundary of that allotment to its easternmost corner in Block XII, Purua Survey District; thence north-westerly along the south-western boundaries, of Lot 3, D.P. 13936 Lots 2 and 1, D.P. 17257, and Lot 1, D.P. 59895, and north-easterly along the north-western boundaries of

Lots 1 and 2, D.P. 59895, and easterly along the southern boundary of Allotment 69, Whangarei Parish, and its production to the middle of the Waiarohia Stream; thence northerly up the middle of the said stream to and up the middle of a tributary of that stream which crosses Lot 3, D.P. 41275, in Block VIII, Purua Survey District, to and then south-westerly along the middle of Whau Valley Road to a point in line with the south-western boundary of Lot 1, D.P. 41275; thence north-westerly along a right line to and along that boundary and then north-easterly along the north-western boundaries of Lots 1, 2, and 3, D.P. 41275, Lot 1, D.P. 38871, and Lot 2, D.P. 51603, and continuing along the generally north-western boundaries of Lots 1, 2, 3, and 7 shown on scheme Plan No. 49 lodged in the Whangarei County office and south-easterly along the north-eastern boundary of the said Lot 7 to the northern side of Whau Valley Road; thence easterly along that roadside to and along the western boundaries of Lot 3, D.P. 57302, to and northerly along a right line between the northernmost corner of the said Lot 3 and the southernmost corner of Lot 2, D.P. 43392; to the northern boundary of Lot 2, D.P. 45066; thence westerly along the generally northern boundary of that Lot 2 to and along the eastern and northern boundaries of Lot 1, D.P. 45066, and north-westerly along the south-western boundaries of Lot 2, D.P. 73713, and the south-western boundaries of Lot 34, D.P. 56009, Lot 1, D.P. 73713, and Lots 14, 13, 12, 11, 10, 9, and 8, D.P. 56009, Lots 11, 10, 9, 8, 7, 6, 5, 4, 3, and 1, D.P. 52362, and along the last-mentioned boundary produced across Three Mile Bush Road to its north-western side; thence south-westerly along that side to and north-westerly along the south-western boundary of that part Otapapa Block shown on D.P. 4543 and along that boundary produced to the south-eastern boundary of Ngatapapa 2 Block; thence north-easterly generally along that boundary and along a right line across Dip Road to the intersection of the eastern side of that road with the middle of the Otapapa Stream and down the middle of that stream to a point in line with the northern boundary of Lot 11, D.P. 44008; thence easterly along a right line to and along that northern boundary to and north-westerly along the south-western boundaries of Lots 12, 13, 14, and 15, D.P. 44008, and Lot 1, D.P. 52017, and north-westerly and north-easterly along the south-western and north-western boundaries of Lot 20, D.P. 44008, and north-easterly along the north-western boundaries of Lots 29, 30, 31, and 32, D.P. 44008, to the northernmost corner of that Lot 32; thence south-easterly along the north-eastern boundaries of Lots 32 to 38 inclusive and Lot 59, D.P. 44008, and the production of that boundary across the Otapapa Stream to its right bank; thence north-easterly generally along that right bank to and along the generally north-western side of the North Auckland Railway to and along the north-western boundary of Lot 33, D.P. 51909, to its northernmost corner; thence northerly generally along the south-western and north-western boundaries of that part Allotment 50, Whangarei Parish, shown on D.P. 1583 to the easternmost corner of Allotment 116, Whangarei Parish, in Block VIII, Purua Survey District, on the right bank of the Waitaua Stream; thence easterly generally along that bank to and southerly along the middle of Gillingham Road to a point in line with the south-eastern boundary of that part of Allotment 50, Whangarei Parish, comprised in certificate of title, Volume 1693, folio 67; thence north-easterly along a right line to and along that south-eastern boundary to and easterly along the right bank of the Waitaua Stream to the western side of Vinegar Hill Road; thence northerly along the production of that western side to and easterly down the middle of Waitaua Stream to and up the middle of the Mangakino Stream to a point in Block I, Whangarei Survey District, in line with the eastern boundary of Kahakaharua 2 Block; thence northerly generally along a right line to and along that boundary and its production to and easterly generally up the middle of the Mangahuru Stream to a point in line with the northern boundary of the Tititahi Block; thence easterly along a right line to and along the northern boundaries of Tititahi Block and Lot 1, D.P. 45058, to and southerly along the eastern boundary of Lot 1, D.P. 45058, and along a right line to the middle of the Ngunguru River; thence north-easterly generally up the middle of that river to a point in line with the northern boundary of Section 21, Block XII, Opuawhanga Survey District; thence easterly along a right line to and along the southern boundary of Section 12, Block XII, Opuawhanga Survey District, to and northerly along the western boundary and easterly along the northern boundary of Block XIII, Opuawhanga Survey District, to and north-westerly along the south-western boundary of Lot 1, D.P. 43116, to and north-easterly along the south-eastern boundaries of Section 23, Block IX, Opuawhanga Survey District, and the last boundary produced across a public road to the line of mean high water of the South Pacific Ocean; thence northerly along that line of mean high water to and across the mouth of the Whangaruru Harbour and again along that line of mean high water to the easternmost point of Section 1, Block XII A, Bay of Islands Survey District, and northerly generally to and along the eastern shores of Percy Island to the northernmost extremity of Percy Island (Motukokako); thence westerly along a right line to the easternmost extremity of Harakeke Island in Block IX, Bay of Islands Survey District, and continuing westerly along the northern shore of that
