DUNEDIN CENTRAL

Ocean Beach Survey District; thence south-easterly to and along that boundary to its easternmost corner; thence south-westerly and south-easterly along the north-western and south-western boundaries of Section 39. Deeds Plan 4, and the production of the last-mentioned boundary to and southeasterly along the north-eastern boundaries of Lot 10, Block II, Deeds Plan 4, and part Section 32. ST. KILDA

H (Chimney); thence north-easterly along a right line to the north-easternmost corner of Section 21, Block VI, Mokoreta Survey District; thence north-westerly along the north-eastern boundary of Block VI, Mokoreta Survey District, and the eastern boundary of Block II, Mokoreta Survey District, to its intersection with the south-eastern boundary of Block VIII, Slopedown Survey District; thence north-easterly along the north-western boundary of Section 6, Block VII, Slopedown Survey District, to the south-western boundary of Part Section 5, Block VII, aforesaid; thence north-westerly along that south-western boundary aforesaid, and its production to the north-western boundary of Lot 7, D.P. 3410, Block VII, aforesaid; thence north-easterly along the north-western boundary of the aforesaid Lot 7 to the Otago-Southland Land District boundary; thence generally north-westerly along that boundary to the southernmost corner of Section 3, Block VI, Slopedown Survey District; thence north-westerly along the south-western boundary of the aforesaid section to the southern side of a road forming part of the northern boundary of Run 251; thence westerly along the southern side of that road to the middle of the north branch of the Mimihau Stream; thence generally south-westerly along the middle of that stream to the eastern boundary of the Tuturau Survey District; thence northerly along the eastern boundary of the Tuturau Survey District, to the middle of the Mataura-Clinton Road situated in Block VIII, Tuturau Survey District; thence generally westerly along the middle of the said road to a point in line with the southwestern boundary of the Closed Road forming the south-western boundary of part Section 1, Block I, Tuturau Survey District; thence north-westerly to and along that boundary and its production to the middle of the Mataura River; thence north-easterly
