

to and across the mouth of the Takou River to and again along that line of mean high water to and westerly and south-easterly generally along the line of mean high water of the Tasman Sea to the point of commencement and including Poor Knights, Three Kings, and other adjacent islands.

WHANGAREI

ALL that area bounded by a line commencing at the easternmost corner of Te Rewarewa B2 in Block XIII, Whangarei Survey District, and proceeding westerly generally along the northern boundaries of Te Rewarewa B2 and B1B, to and southerly along the western boundary of Te Rewarewa B1A3A along a right line across a public road to and southerly along the western boundaries of Te Rewarewa B1A2 and B1A1, and the western and south-western boundaries of Te Rewarewa A, to and south-westerly generally up the middle of Te Waiiti Stream to and southerly along the western side of State Highway No. 1, to and along the south-eastern boundary of Lot 1, D.P. 33086, to a point in line with the south-western boundary of Lot 2, D.P. 40082; thence north-westerly along a right line to and along that boundary, south-westerly along the north-western boundary of the said Lot 1, D.P. 33086; and again north-westerly along the north-eastern boundaries of Section 22, Block XVI, Purua Survey District, Ruarangi Block, and Section 20, Block XVI, aforesaid, to and north-easterly along the south-eastern boundaries of Lot 2, D.P. 46220, Lot 4, D.P. 19724, and Lot 17, Deeds Plan 130, and the last-mentioned boundary produced to and westerly generally up the middle of the Raumanga Stream to a point in the said Block XVI in line with the north-eastern boundary of Lot 2, D.P. 28097; thence north-westerly along a right line to and along that boundary and that boundary produced to the north-western side of State Highway No. 14 and north-easterly generally along that north-western side to and along the western boundary of Section 11, Block XII, Purua Survey District, and that boundary produced to and down the middle of the Te Hihī Stream to a point in line with the eastern boundary of Lot 1, D.P. 62528; thence northerly along a right line to and along the eastern and north-eastern boundaries of that Lot 1 and the production of the last-mentioned boundary across a public road to its northern side; thence again easterly generally along the northern side of that public road forming the southern boundaries of Allotments 5 and part 4 of Pukenui 1 and part Taikawiwi Block, and continuing along the northern side of State Highway No. 14 shown coloured burnt sienna on S.O. Plan 47372 to and northerly generally along the western boundaries of Lots 3, 2, and 1, D.P. 39096, to and easterly along the northern boundary of the last-mentioned lot and continuing easterly along the southern boundary to and northerly along the eastern boundary of part Horahora 2 shown on D.P. 568 to and south-easterly along the north-eastern boundary of Lot 2, D.P. 57146, to and north-easterly along the south-eastern boundary of Section 2, Block XII, Purua Survey District (Coronation Scenic Reserve), to and along a series of right lines crossing the said Section 2, being the generally south-eastern boundary of part Horahora 2 as shown on S.O. Plan 16342 to and along the north-eastern boundary of that Section 2 to its northernmost point; thence easterly generally along the southern boundary of the Bay of Islands Electoral District as hereinbefore described, to its intersection with the line of mean high water of the South Pacific Ocean in Block IX, Opuawhanga Survey District; thence southerly and westerly generally, along that line of mean high water crossing the mouths of all harbours and inlets, to and west of the northernmost corner of Lot 1, D.P. 58877; thence northerly along a right line to another point on the line of mean high water of the Whangarei Harbour due west of a point on the north-eastern boundary of Lot 2, D.P. 46909, being the northernmost corner of Lot 1, D.P. 42421; thence north-westerly along a right line between that last-mentioned point on the line of mean high water of the harbour and a point in line with the south-eastern boundary of Section 24, Block IX, Whangarei Survey District, distant 221.28 metres, in a south-westerly direction from the southernmost corner of the said Section 24, to the intersection of that right line with a right line taken due east from a point 201.27 metres due south of the south-eastern corner of Section 5, Block XIII, Whangarei Survey District; thence due west along that last-mentioned right line and that line continued to a point due south of another point, on the north-western side of the North Auckland Railway, distant 150.88 metres measured in a south-westerly direction along that north-western side from the easternmost corner of Te Rewarewa B2; thence due north, to and along the north-western side of that railway to the point of commencement, and including the Hen and Chickens Islands, the Mokohinau Islands, and other adjacent islands.

ALL that area bounded by a line commencing at the northernmost corner of Section 2, Block XII, Purua Survey District (Coronation Scenic Reserve) and proceeding generally south-easterly along the generally south-western boundary of the Electoral District of Whangarei, hereinbefore described, to the mean high-water mark of the Whangarei Harbour; thence generally south-westerly and easterly along the line of mean high-water of Whangarei Harbour to and southerly generally along the line of mean high-water of the Hauraki Gulf and across the mouth of the Waiwera River to and westerly up the middle of that river, and the middle of the channel of that river south of Te Koroto Block and again up the middle of Waiwera River to a point in line with the north-western boundary of Allotment 104, Waiwera Parish, in Block III, Waiwera Survey District; thence south-westerly along a right line to and along that north-western boundary to and westerly along the northern boundaries of Allotments 101, 102, 103, 242, and 256 and along that last boundary produced to and up the middle of the Waiwera River to a point in line with the northern boundary of Allotment 89, in Block II, Waiwera Survey District; thence westerly along a right line to and along that northern boundary, to and along the northern side of that part of the Upper Waiwera Road forming the northern boundaries of Lot 1, D.P. 50186, Lot 1, D.P. 66462, and part Allotment 89, and along a right line across the Upper Waiwera Road to and westerly along the northern boundaries of Allotment 286, Lot 2, D.P. 39203, along a right line across Bayers Road and a stream to and along the northern boundaries of Allotments 283 and 272, crossing the intervening Upper Waiwera Road and the Waiwera Stream, Allotment 270, Lot 2, D.P. 71340, Allotment N134 crossing the intervening Broady Road, Allotments 466, N113, 112, crossing the intervening Upper Waiwera Road, all the aforesaid allotments being of Waiwera Parish, to the easternmost corner of Lot 5, D.P. 26487, in Block I, Waiwera Survey District; thence northerly along the eastern boundary of Lot 5, D.P. 26487, along a right line across the Upper Waiwera Road to and along the eastern boundary of Lot 4, D.P. 26487, along a right line across a public road, to and along the eastern boundary of Lot 3, D.P. 26487, Allotment 232, Makarau Parish, along a right line across the Puhoi-Tahekeroa Road and Tahekeroa Stream, along the eastern boundaries of Lot 2, D.P. 20898, that part of Allotment 185 shown on D.P. 18176, along a right line across the North Auckland Railway and Rauner Road, along the eastern boundary of Allotment 188, to its northernmost corner in Block XIII, Mahurangi Survey District; thence south-westerly along the north-western boundaries of that part of the aforesaid Allotment 188 as shown on D.P. 2543, Lot 3, D.P. 11758, Allotments N187 and N186, to and north-westerly along the north-eastern boundary of Allotment N64, all the aforesaid allotments being of Makarau Parish, and along the production of that last boundary to and down the middle of the Rauhori Stream, and the middle of the Makarau River, to its junction with the eastern shore of Kaipara Harbour; thence westerly and north-westerly down the middle of the Kaipara Harbour to and south-westerly along the middle of the Kaipara Entrance to its junction with the sea coast of the Tasman Sea; thence north-westerly along that sea coast to and along the line of mean high-water of the Tasman Sea and across the southern mouth of the Waipoua River to the middle of that mouth in Block V, Waipoua Survey District; thence easterly along the southern boundary of the Bay of Islands Electoral District hereinbefore described to the point of commencement and including, Kawau Island, Motouora Island, and any other adjacent islands.

HELENSVILLE

ALL that area bounded by a line commencing at a point in the middle of the mouth of the Anawhata Stream in Block I, Waitakere Survey District, and proceeding easterly generally up the middle of that stream to a point in line with the south-western boundary of Allotment M44, Waitakere Parish; thence northerly along a right line to and easterly generally along the southern boundaries of Allotments M44, NE44, SW45, and Lot 1, D.P. 10267, the last-mentioned boundary produced across Ridge Road to and northerly along the western boundaries of Allotment 52 to and easterly generally along the southern boundaries of Allotment 103, the last-mentioned boundary produced to the middle of the Waitakere Scenic Drive in Block I, Titirangi Survey District, all the aforesaid allotments being of Waitakere Parish; thence south-easterly generally along the said middle line of the Waitakere Scenic Drive to and north-easterly generally along the middle of Waikumete West Coast Road to and along the middle of Forest Hill Road to and along the middle of Holdens Road to and easterly along the middle of Parris Cross Road to the middle of the Oratia Stream in Block II, Titirangi Survey District; thence northerly down the middle of that Stream to a point in line with the southern boundary of Lot 1, D.P. 64778; thence westerly along a right line to and along the last-mentioned boundary and the
