

western boundary of Allotment 95, Takapuna Parish, to the northernmost corner of Lot 9, D.P. 52111, and along the north-western boundary of that lot, along a right line across Lynden Avenue, to and along the north-western boundaries of Lots 10, 12, 13, 14, 15, and 16, D.P. 52111, and Lot 6, D.P. 63629, along a right line across Eban Avenue to and along the north-western boundaries of Lots 7, 8, 9, 10, and 11, D.P. 63629, Lots 49 to 40 inclusive, 38 and 36, D.P. 56937, and the south-eastern boundaries of Lots 10, 12, 13, 84, 14, 15, 16, and 17, D.P. 55687, to and westerly along the southern boundaries of Lot 4, D.P. 54271, Lots 71 and 69, D.P. 57991, and the last boundary produced across Betsland Crescent and Lots 3 and 4, D.P. 57991, to and along the southern boundaries of Lots 5, 73, and 72, D.P. 57991, and Lot 1, D.P. 40090, the last boundary produced to the middle line of Glenfield Road; thence southerly along that middle line to and westerly and north-westerly along the middle of Eskdale Road to a point in line with the north-eastern boundary of Lot 13, D.P. 49922; thence north-westerly along a right line to and along the north-eastern boundaries of that Lot 13 and Lots 12, 11, 10, and 1, D.P. 49922, and part Allotment 126, Takapuna Parish (Scenic Reserve, *Gazette*, 1974, page 2077), to the easternmost corner of Lot 57, D.P. 53847; thence south-westerly along the south-eastern boundaries of Lots 57, 82, 80, and 56, D.P. 53847, Lots 2 and 1, D.P. 73088, Lots 54, 53, and 78, D.P. 53847, and that last boundary produced across the Kaipatiki Stream to the line of mean high-water of the left bank of the Kaipatiki Stream; thence northerly and westerly generally along the line of mean high-water of the Waitemata Harbour, and its creeks, to a point in line with the north-eastern boundary of Lot 1, D.P. 67280, in Block VI, Waitemata Survey District; thence northerly generally along the boundary of the Helensville Electoral District, hereinbefore described, to the junction of the middle line of Jelas Access Road with the line of mean high-water of the Orewa River; thence easterly generally along that line of mean high-water to and easterly, westerly, northerly, and southerly generally along the line of mean high-water of the Hauraki Gulf and its rivers and inlets to the point of commencement, and including all that area bounded by a line commencing at the junction of the eastern boundary of the Helensville Electoral District, hereinbefore described, and the southern boundary of the Kaipara Electoral District, hereinbefore described, and proceeding easterly along the said southern boundary to the middle of the mouth of the Waiwera River; thence southerly across that mouth to and along the line of mean high-water of the Hauraki Gulf to and westerly along the line of mean high-water of the Orewa River, to and northerly along the said eastern boundary of the Helensville Electoral District to the point of commencement, and including Tiritiri Matangi Island and other adjacent islands.

EAST COAST BAYS

ALL that area bounded by a line commencing at the intersection of the middle of Archers Road with the middle of Auckland Waiwera Motorway, in Block VIII, Waitemata Survey District, and proceeding south-easterly and north-easterly along the middle of Archers Road, Allotment 550, Takapuna Parish, and Forest Hill Road, to a point in line with the south-eastern boundary of Lot 1, D.P. 51102; thence north-easterly along a right line to and along that boundary and the south-eastern boundaries of Lot 1, D.P. 62267, and Lot 22, D.P. 51550, along a right line across Corunna Road to and along the south-eastern boundaries of Lots 21, 16, and 15, D.P. 51550, Lot 2, D.P. 74124, and along a right line across Nile Road to the southernmost corner of Lot 7, D.P. 45968; thence north-westerly along the south-western boundary of that Lot 7 to and northerly along the eastern boundaries of Lots 26, 25, 24, 23, 22, 21, 20, and 19, D.P. 52216, Lots 58, 57, 56, 55, 54, 53, 52, and 51, D.P. 52972, along a right line across Marsh Avenue to and along the eastern boundaries of Lots 89, 88, 87, and 85, D.P. 53364, Lot 47, D.P. 57533, Lot 210, D.P. 58605, and the western boundaries of Lots 32, 31, 28, 27, 24, 23, 20, 19, 17, and 16, D.P. 47869, to and easterly along the northern boundaries of Lots 16, 15, 14, 13, 12, 11, 10, and 9, D.P. 47869, Lot 1, D.P. 51864, Lots 5, 4, 3, 2, and 1, D.P. 47869, and Lot 1, D.P. 32800, and the last boundary produced to and northerly along the middle of East Coast Road to and north-easterly generally along the middle lines of Dewsbury Terrace, Parr Terrace, Seaview Road, and Marama Street to and easterly along the middle of Rahopara Street and the last middle line produced to the line of mean high water of the Hauraki Gulf; thence northerly generally along that line of mean high water to the easternmost corner of Lot 3, D.P. 78206, in Block XVI, Waiwera Survey District; thence westerly and southerly generally along the boundary of the Albany Electoral District, hereinbefore described, to the point of commencement.

BIRKENHEAD

ALL that area bounded by a line commencing on the line of the mean high water of the Waitemata Harbour in Shoal Bay on the southernmost corner of Lot 74, D.P. 45481, in Block XII, Waitemata Survey District, and proceeding north-westerly along the south-western boundary of that Lot 74 to and along the south-western boundary of Lot 1, D.P. 31225, to and along a right line across Northcote Road to and along the south-western boundaries of Allotment 482, Takapuna Parish, to the easternmost corner of Lot 2, D.P. 77171; thence south-westerly and north-westerly along the boundary of the Albany Electoral District, hereinbefore described, to a point in line with the western boundary of part Allotment 126, Takapuna Parish; thence northerly along a right line to and along that western boundary to the line of mean high water of the Kaipatiki Creek; thence westerly, south-easterly, easterly, and northerly generally along the line of mean high water of the Waitemata Harbour and its creeks to the point of commencement; including the Chelsea Wharves, and all adjoining wharves.

NORTH SHORE

ALL that area bounded by a line commencing at the south-eastern corner of Lot 2, D.P. 77171, in Block VIII, Waitemata Survey District, and proceeding north-westerly along the south-western boundaries of Allotments 482 and 483, Takapuna Parish, Lots 2 and 1, D.P. 53045, the south-western end of Porana Road, the south-western boundary of Lot 2, D.P. 66602, and Lot 17, D.P. 8521, and the last boundary produced to the middle of Archers Road; thence north-easterly along the middle of Archers Road to its intersection with the middle of the Auckland Waiwera Motorway; thence north-easterly generally along the boundary of the East Coast Bays Electoral District hereinbefore described to its junction with the line of mean high water of the Hauraki Gulf; thence south-easterly along the line of mean high water of the Hauraki Gulf to and westerly and northerly generally along the line of mean high water of the Waitemata Harbour to the southernmost corner of Lot 74, D.P. 45481, in Block XII, Waitemata Survey District; thence north-westerly along the boundary of the Birkenhead Electoral District, hereinbefore described, to the point of commencement.

WAITAKERE

ALL that area bounded by a line commencing at the easternmost corner of Lot 21, D.P. 43825, in Block III, Titirangi Survey District, and proceeding westerly along the northern boundaries of the said Lot 21 and Lot 20, D.P. 43825, to and southerly generally along the western boundary of the said Lot 20 to the easternmost corner of Lot 19, D.P. 43825; thence south-westerly along a right line, crossing Alston Avenue to and again south-westerly along the eastern boundaries of Lot 16, D.P. 43825, Lots 3 to 10 inclusive, D.P. 43457, Lots 1 and 2, D.P. 47198, Lot 2, D.P. 62445, Lots 4, 5, and 9, D.P. 47198, along a right line across Carlisle Road to and southerly along the eastern boundaries of Lot 23, D.P. 47198, Lot 2, D.P. 31889, Allotment 198, Waikomiti Parish, to and easterly along the northern boundary of Allotment 196, Waikomiti Parish, and that boundary produced to and southerly along the middle of Lynwood Road, to and westerly along the middle of Great North Road to a point in line with the eastern boundary of Lot 17, D.P. 39837; thence southerly along a right line to and along that eastern boundary and the eastern boundaries of Lots 14, 13, 12, and 11, D.P. 39837, and the western boundary of Allotment 468, Waikomiti Parish, to its westernmost corner, thence along right lines crossing the North Auckland Railway bearing 198° 01' distant 14.54 metres and bearing 108° 01' distant 83.17 metres, to the north-eastern corner of Lot 22, D.P. 20071; thence south-westerly along the south-eastern boundary of that Lot 22, along a right line across Liverpool Street and again south-westerly along the south-eastern boundaries of Lots 23, 24, 25, and 26, D.P. 20071, to and south-easterly along the south-western boundaries of Lots 3 and 7, D.P. 55101, and Lot 13, D.P. 22025, and that last boundary produced to and southerly along the middle of Fruitvale Road, to its intersection with the eastern side of Croydon Road; thence along a right line across Croydon Road, to and south-westerly along the south-eastern boundary of Lot 3, D.P. 40935, to and south-westerly along the north-western boundaries of Lot 3, Deeds Plan 232, and Lot 4, D.P. 48735, to and south-easterly along the north-eastern boundary of Allotment 138, Waikomiti Parish, along a right line across Titirangi Road to and south-easterly along the north-eastern boundaries of Lot 9, D.P. 23375 (Plantation Reserve), Lots 5 and 7, D.P. 39449, along a right line across West Lyn Road to and south-easterly along the north-eastern boundaries of Lot 1, D.P. 10388, and Lot 3, D.P. 64801, and that boundary produced to the westernmost corner of Lot 5, D.P. 60351; thence south-easterly along the south-western boundary of that Lot 5 to and north-easterly along the south-eastern boundaries of Lot
