

along the northern, eastern, and southern boundaries of the last-mentioned lot to the eastern side of Gray Street; thence southerly and westerly along that roadside to the eastern side of MacKenzie Country Road (No. 8 S.H.); thence southerly along that roadside to a point in line with the southern boundary of Lot 10, D.P. 3007; thence westerly to and along that boundary, the southern boundary of Lot 11, D.P. 3007, the abutment of Gall Street and the southern boundary of Lot 24, D.P. 325, to the western boundary of the last-mentioned lot; thence northerly along that boundary to a line parallel to, and 50 metres south of, the southern side of Hamilton Street; thence westerly along that line to the eastern boundary of Lot 3, D.P. 11364; thence northerly along that boundary to the south side of Hamilton Street; thence westerly along that roadside and northerly along the western side of Gillingham Street to the southern boundary of Lot 9, D.P. 2690; thence westerly along that boundary and the southern boundary of that part of Rural Section 22444 comprised in C.T. 141/19, to the south-western corner of that part Rural Section; thence northerly along the western boundary of that same part Rural Section to the southern side of School Road; thence westerly along that roadside to a point in line with the western boundary of Lot 1, D.P. 3688; thence to and along that boundary and the western abutment of Regent Street to the northern side of that street; thence easterly along the northern side of Regent Street to the eastern boundary of that part of Rural Section 10479 comprised in C.T. 3A/1236; thence northerly along that boundary to the northern boundary of that part of Rural Section 10479 taken for a Main Highway Depot by *New Zealand Gazette*, 1950, page 103; thence easterly along that boundary to the south-western boundary of Lot 20, D.P. 4011; thence north-westerly along the south-western boundaries of that lot, Lots 19, 18, 17, 16, 15, 14, 13, and 12, D.P. 4011, and the south-western abutment of Ayr Street to the south-eastern boundary of Lot 1, D.P. 38134; thence south-westerly and north-westerly along the south-eastern and south-western boundaries of that lot to its westernmost corner; thence north-easterly along the north-western boundaries of Lots 1, 2, 3, 4, 5, 6, D.P. 38134, to the northernmost corner of the last-mentioned lot; thence north-westerly along the north-eastern boundary of that part of Rural Section 22384 comprised in C.T. 489/229 to the point of commencement.

Boundaries of the District of Waipukurau Defined

PURSUANT to section 16 of the Counties Act 1956, the Secretary for Local Government hereby defines, as set out in the Schedule hereto, the boundaries of the District of Waipukurau; the district having previously been formed by the union of the County and Borough of Waipukurau by Order in Council, made on 28 March 1977, and published in the *New Zealand Gazette*, No. 36, 31 March 1977, page 943.

SCHEDULE

BOUNDARIES OF DISTRICT OF WAIPUKURAU

ALL that area in the Hawke's Bay Land District containing 2031 square kilometres, more or less, bounded by a line commencing at a point being the middle of the confluence of the Tukituki and Waipawa Rivers in Block XVI, Waipukurau Survey District, and proceeding northerly generally, up the middle of the old Waipawa River bed to the middle of Home-wood Road; thence north-westerly along the middle of that road and its production to the north-western side of Race-course Road; thence north-westerly along a right line to the easternmost corner of Block 14, Patangata Crown Grant District; thence north-westerly along the north-eastern boundaries of that block and Block 85, Patangata Crown Grant District, and the production of the last-mentioned block to the middle of the No. 2 State Highway; thence northerly along the middle of that highway to the middle of the junction of Boundary Road; thence generally easterly, southerly, and north-easterly along the middle of that last-named road and Te Aute Trust Road to and south-westerly along the middle of Middle Road to the middle of the Papanui Stream; thence down the middle of that stream, to and down the middle of the Tukituki River, to and up the middle of the Hawea Stream, to a point in line with the northern boundary of Lot 1, D.P. 14568; thence easterly to and along that boundary, across Kahuranaki Road, to and along the northern

boundary of part Section 4, Block III, Oero Survey District; thence southerly along the eastern boundaries of that section, Lot 2 of Section 5, and Section 6, all in Block III, Oero Survey District, to the northern boundary of Lot 1, D.P. 3215; thence easterly along that last-mentioned boundary and the northern boundary of Lot 2, D.P. 3216, to the sea coast (including the crossing of Waipoapoa Road, Te Apati Road, and an unnamed road); thence generally south-westerly along the sea coast to the south-western boundary of part Lot 3, D.P. 549; thence north-westerly and north-easterly along the south-western and north-western boundaries of the said part Lot 3 (including the crossing of Seaview Road), and the production of the last-mentioned boundary to the middle of the Papuka Stream; thence up the middle of that stream to a point in line with south-western boundary of Block 83, Tautane Crown Grant District; thence north-westerly and north-easterly to and along that boundary and the north-western boundary of the said Block 83 to its northernmost corner; thence north-westerly along the south-western boundaries of Blocks 86 and 27, Tautane Crown Grant District, to the south-eastern boundary of Block 75, Tautane Crown Grant District; thence south-westerly along that boundary and the south-eastern boundary of Block 79, Tautane Crown Grant District; thence north-easterly along the north-western boundary of the said Block 79 and across Mangaone Road to a point in line with the south-western boundary of Block 84, Tautane Crown Grant District; thence north-westerly and north-easterly to and along the south-western and north-western boundaries of the said Block 84 to the easternmost corner of Section 7, Block IX, Tautane Survey District; thence north-westerly along the north-eastern boundary of the said Section 7 to the eastern boundary of Section 2, Block IX, Tautane Survey District; thence northerly along that boundary and the eastern boundaries of Section 9, and part Section 6, Block V, Tautane Survey District, across No. 52 State Highway, to and along the eastern boundaries of Section 14, Blocks V, Tautane Survey District, and Lot 4 of Section 1, Block I Tautane Survey District, across Birch Road East to and along the eastern boundary of Section 4, Block I, Tautane Survey District to the south-western boundary of Mangamaire B13B Block; thence north-westerly along the south-western boundaries of the said Mangamaire B13B Block, Section 7, Block I, Tautane Survey District, Ngapaeruru 7E Block, Lots 2 and 1, D.P. 7642, to the westernmost corner of Ngapaeruru 7C Block; thence north-easterly along the north-western boundary of Ngapaeruru 7C Block aforesaid to the south-western boundary of Section 4, Block XIII, Porangahau District; thence north-westerly along the south-western boundaries of that Section 4 and Section 7, Block XIII, Porangahau Survey District, to the northernmost corner of part Section 1, Block XVI, Mangatoro Survey District; thence south-westerly along the north-western boundary of the said part Section 1 for a distance of 342 metres; thence due west to a point on the south-western boundary of Section 6, Block XV, Mangatoro Survey District; thence north-westerly along that boundary to the most north-western corner of the said Section 6; thence generally easterly along the northern boundaries of Section 6 aforesaid, and Section 5, Block XV, Mangatoro Survey District, to the southernmost corner of Section 2, Block XII, Mangatoro Survey District; thence northerly generally along the eastern boundary of the said Section 2, across Te Uri Road to and along the eastern and northern boundaries of Section 3, Block VIII, Mangatoro Survey District to Trig Station XII; thence north-westerly along a right line to Trig Station 27 (Taumataniui); thence north-westerly along a right line to the westernmost corner of Wharawhara Block; thence north-westerly along that right line aforesaid and its production to the middle of the Manga-puka Stream; thence down the middle of that stream to and up the middle of the Whangai Stream to and northerly along the eastern boundary of Section 14, Block XV, Takapau Survey District, to and down the middle of the Taurekaitai Stream to and up the middle of the Whatauna Stream to a point in line with the south-western boundary of Lot 3, D.P. 4265; thence north-westerly to and along that boundary and the south-western boundaries of part Lot 2 and Lot 1, D.P. 4265, aforesaid to and down the middle of the Mangapurakau Stream to a point in line with the north-western boundary of Lot 2, D.P. 2162; thence north-easterly to and along that boundary, across a public road to and again along the north-western boundary of the said Lot 2 to the south-western boundary of Lot 1, Deeds Plan 455; thence north-westerly along that boundary, across a public road to and again along the south-western boundary of the said Lot 1 to its westernmost corner; thence north-easterly generally along the north-western boundaries of that lot and Section 5, Block VII, Takapau Survey District, to the northernmost corner of that section; thence easterly and southerly generally along the northern and eastern boundaries of the said Section
