Declaring Land Acquired for a Local Work to be Crown Land

A PROCLAMATION

PURSUANT to the Public Works Act 1928, I, Sir Edward Denis Blundell, the Governor-General of New Zealand, hereby declare the land described in the Schedule hereto to be Crown land subject to the Land Act 1948.

SCHEDULE

HAWKE'S BAY LAND DISTRICT

ALL that piece of land containing 5.7935 hectares, being part Section 27, Block XI, Waipukurau Survey District; as shown on plan S.O. 7051 lodged in the office of the Chief Surveyor at Napier.

Given under the hand of His Excellency the Governor-General, and issued under the Seal of New Zealand, this 11th day of May 1977.

THE RIGHT HON. B. E. TALBOYS PRESIDING IN COUNCIL

PURSUANT to the Electric Power Boards Act 1925, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- (i) This order may be cited as the Hutt Valley Electric Power District Representation Order 1977.
- (ii) This order shall come into force on the date of the next general election of members of local authorities.
2. The constituent districts of the Hutt Valley Electric Power District, which are bracketed together in the first column of the Schedule hereto, shall be combined districts for the purposes of the said Act.
