Declaring Land Acquired for a Local Work to be Crown Land

PURSUANT to the Public Works Act 1928, I, Sir Edward Denis Blundell, the Governor-General of New Zealand, hereby declare the land described in the Schedule hereto to be Crown land subject to the Land Act 1948.

ORDER IN COUNCIL

At the Government Buildings at Wellington this 27th day of June 1977

THE RIGHT HON. B. E. TALBOYS PRESIDING IN COUNCIL

PURSUANT to the Electric Power Boards Act 1925, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. (i) This order may be cited as the Hutt Valley Electric

Power District Representation Order 1977. (ii) This order shall come into force on the date of the next general election of members of local authorities. 2. The constituent districts of the Hutt Valley Electric Power District, which are bracketed together in the first column of the Schedule hereto, shall be combined districts for the surface of the sold Act for the purposes of the said Act.

3. The local authority of the constituent district distinguished in the first column of the Schedule by the letter "(P)" shall be the principal local authority of the combined district of which it forms a part.

4. The number of representatives of each constituent district or combined district of the Hutt Valley Electric Power District on the Hutt Valley Electric Power and Gas Board shall be the number specified in the Schedule hereto opposite the name of that constituent district or combined district.

5. The Order in Council apportioning representation on the Hutt Valley Electric Power and Gas Board dated the 24th day of September 1974, and published in the New Zealand Gazette on the 11th day of July 1974, on p. 1392 is hereby revoked.
