Amending a Proclamation Revoking in Part Proclamations Taking Land for Soil Conservation and River Control Purposes in Blocks X and XI, Puketi Survey District, Taupo County

DENIS BLUNDELL, Governor-General A PROCLAMATION

PURSUANT to section 330a of the Public Works Act 1928, I, Sir Edward Denis Blundell, the Governor-General of New Zealand, hereby amend the Proclamation, dated 3 August 1976, and published in the New Zealand Gazette, of 12 August 1976, at page 1863, revoking in part Proclamations taking land for soil conservation and river control purposes by omitting the First and Second Schedules thereto and substituting the following First and Second Schedules.

FIRST SCHEDULE

WELLINGTON LAND DISTRICT
