(2) The electors of Mangaiti, Komata and Waihi Beach Ridings shall each elect one councillor.

4. The alterations hereby made shall take effect at the next general election of the council, viz, the 8th day of October 1977, except in so far and to such extent as may be necessary for preparing any roll or otherwise providing for that election.
