Mount Richmond State Forest Park*

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 63B (2) of the Forests Act 1949, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby declares that the area of State forest land described in the Schedule hereto, having been set apart as Mount Richmond State Forest Park by a Proclamation dated the 28th day of February 1977, and published in *New Zealand Gazette*, 3 March 1977, Vol. 23, p. 445, hereby ceases to be part of Mount Richmond State Forest Park as from the date of publication hereof.

*Notice of Intention to Vary Hours of Sale of Liquor at
Licensed Premises—Marlborough Licensing Committee*

PURSUANT to section 221A of the Sale of Liquor Act 1962, as amended by section 22 (14) of the Sale of Liquor Amendment Act 1976, I, Bruce James Cameron, Acting Secretary for Justice, hereby give notice that the Marlborough Licensing Committee, on 30 November 1978, made an order authorising variations of the usual hours of trading for the licensed premises shown in the Schedule below.

To the intent that on days other than those on which licensed premises are required to be closed for the sale of liquor to the public the hours for the opening and closing of the said premises shall be as follows:

- (a) On any Monday, Tuesday, Wednesday, and Thursday (not being Christmas Eve or New Year's Eve)—Opening at 11 o'clock in the morning and closing at 10 o'clock in the evening.
- (b) On any Friday, Saturday (not being New Year's Eve) and Christmas Eve—Opening at 11 o'clock in the morning and closing at 11 o'clock in the evening.
- (c) On New Year's Eve—Opening at 11 o'clock in the morning and closing at 00.30 o'clock in the morning of New Year's Day.
