thence northerly generally along the generally eastern boundaries of Maungataniwha West, No. 2 Block, Section 9, Block IX, Maungataniwha Survey District, along a right line across State Highway No. 1, to and along the eastern boundaries of Section 8, Block IX, Maungataniwha Survey District, along the end of a Public Road to and along the eastern boundaries of Allotments 232 and 124, Maungataniwha Parish, to the northernmost corner of Maungamuka West 3AA Block; thence easterly generally along the generally northern boundaries of Maungamuka West 3AA and 3D Blocks, Lot 1, D.P. 29154, and Section 2, Block X, Maungataniwha Survey D.F. 29154, and Section 2, block A, Maungataniwna Survey District, to the northernmost corner of that Section 2; thence north-easterly generally along the generally south-eastern boundaries of part Maungataniwha West, No. 1 Block, taken for State Forest by New Zealand Gazette 1906, p. 1428, and Maungataniwha East Block, to and easterly along the northern boundaries of Section 1 and 1A, Block VII, Maungataniwha Survey District, to a point in line with the western boundary of Allotment 71, Maungataniwha East Parish, as shown on S.O. Plan 18572; thence northerly along a right line to and along that western boundary to and easterly along the northern houndary of thet Allotment 71 to the rood angle by page boundary of that Allotment 71 to the road angle by peg LXXXV, as shown on S.O. Plan 18572; thence north-easterly across that road angle to and along the generally north-western boundaries of Allotment 69, Maungataniwha East Parish, to and north-westerly along the south-western boundaries of Allotments SW95 and SW96, Kohumaru Parish, to and north-easterly along the south-eastern side of a public road forming the north-western boundaries of Allotments SW96, M96, NE96, SW97, NE97, SW98, SW M98, M98, NE98, 99, 104, 105, SW108, M108, NE108, and 109, Kohumaru Parish, and Maungahoutoa Block, to and easterly along the northern boundary of that block to its northernmost corner; thence northerly generally along the generally eastern boundary of Muritoki Block and the last boundary produced to the middle of Stony Stream, in Block XI, Mangonui Survey District; thence northerly up the middle of Stony Stream, to the north-castern side of the public road forming the southwestern boundaries of Allotment S61, Mangonui East Parish; thence north-westerly along that roadside and continuing northerly generally along the generally western boundaries of Allotments S61, N61, Section 9, Block VII, Mangonui Survey District, and Motukahakaha Block, to the westernmost corner of that Motukahakaha Block; thence northerly along a right line to the north-westernmost corner of Lot 1, D.P. 12803, in Block III, Mangonui Survey District, and along the production of that right line to the line of mean high water of the South Pacific Ocean; thence north-westerly along that line of mean high water to and south-easterly along that of mean high water of the Tasman Sea to the point of com-mencement and including all adjacent islands, islets, and rocks, but excluding Three Kings Islands and excluding the Borough of Kaitaia as hereinbefore described.
