Redefining the Boundaries of the North Canterbury Electric Power District

> KEITH HOLYOAKE, Governor-General A PROCLAMATION

PURSUANT to the Electric Power Boards Act 1925, I, Sir Keith Jacka Holyoake, the Governor-General of New Zealand, hereby re-define the boundaries of the North Canterbury Electric Power District as set out in the Schedule hereto.

#### SCHEDULE

ALL that area, in the Canterbury, Marlborough, and Nelson Land Districts bounded by a line commencing at the middle of the mouth of the Waimakariri River, Block IV, Christchurch Survey District, and proceeding north-westerly generally up the middle of that river to a point in line with the northeastern boundary of Rural Section 14216; thence south-easterly to and along that boundary, the north-eastern boundary of Rural Section 17167, and the production of the last mentioned boundary to the left (western) bank of the Styx River; thence southerly, generally, along that bank to a point in line with the northernmost corner of part Lot 3, D.P. 9363, comprised in C.T. 12F/259; thence westerly to and along the northern boundary of that part lot, and the generally northern boundary of Reserve 1835, to the eastern boundary of Part Rural Section
