

*Notice of Intention to Vary Hours of Sale of Liquor at Licensed Premises—Northland Licensing Committee*

PURSUANT to section 221A of the Sale of Liquor Act 1962, as amended by section 22 (14) of the Sale of Liquor Amendment Act 1976, I, Gordon Stewart Orr, Secretary for Justice, hereby give notice that the Northland Licensing Committee on 17 March 1978 made an order authorising variations of the usual hours of trading for the licensed premises known as the Kaihu Tavern, at Kaihu, Dargaville.

- (b) On every Friday and Christmas Eve (Christmas Eve not being a Saturday) the hour of opening shall be 11 o'clock in the morning and the hour of closing 11 o'clock in the evening.
- (c) On every Saturday (including Christmas Eve but not including New Year's Eve) the hour of opening shall be 10 o'clock in the morning and the hour of closing 10 o'clock in the evening.
- (d) On every New Year's Eve the hour of opening shall be at 11 o'clock in the morning and the hour of closing 0.30 o'clock in the morning of New Year's Day.
