KEITH HOLYOAKE, Governor-General A PROCLAMATION

Pursuant to section 421 of the Maori Affairs Act 1953, I, The Right Honourable Sir Keith Jacka Holyoake, the Governor-General of New Zealand, hereby declare the land described in the Schedule hereto and comprised in roadways laid out by the Maori Land Court by orders dated the 27th day of August 1965, the 20th day of April 1971, and the 20th day of October 1971, to be road, and to be vested in the Chairman, Councillors, and Inhabitants of the County of Bay of Islands.
