PURSUANT to the Public Works Act 1928, I, The Right Honourable Sir Keith Jacka Holyoake, the Governor-General of New Zealand, hereby proclaim and declare that the land described in the First Schedule hereto is hereby taken for road and that the land described in the Second Schedule hereto is hereby taken for stream diversion and shall vest in the Chairmon Councillor and Inhabitants of the County of the Chairman, Councillors, and Inhabitants of the County of Franklin, as from the date hereinafter mentioned; and I also declare that this Proclamation shall take effect on and after the 4th day of May 1978.
