Notice of Intention to Vary Hours of Sale of Liquor at Chartered Club Premises—Canterbury Licensing Committee

PURSUANT to section 221A of the Sale of Liquor Act 1962 as amended by section 22 (14) of the Sale of Liquor Amendment Act 1976, I, Gordon Stewart Orr, Secretary for Justice, hereby give notice that the Canterbury Licensing Committee, on 7 April 1978, made an order authorising variations of the usual hours of trading for the chartered club premises known as the Christchurch Returned Services Association (Inc.) Christchurch.

To the intent that on days other than those on which chartered clubs are required to be closed for the sale of liquor to their members, the hours for the opening and closing of the said premises shall be as follows:

- On any Monday, Tuesday, Wednesday, Thursday, Friday, and alternate Saturday). Opening at 11 o'clock in the morning and closing at 10 o'clock in the evening.
- On every alternate Saturday commencing on the Saturday following publication of notification in the *New Zealand Gazette*. Opening at 11 o'clock in the morning and closing at 11 o'clock in the evening.

- On any Friday, Saturday (not being New Year's Eve), and Christmas Eve. Opening at 11 o'clock in the morning and closing at 11 o'clock in the evening.
- On New Year's Eve. Opening at 11 o'clock in the morning and closing at 0.30 o'clock in the morning of New Year's Day.
