Revoking an Area of Land, Patea District, to be a Wildlife Refuge in the Hawera Acclimatisation District

A PROCLAMATION

PURSUANT to section 14 of the Wildlife Act 1953, I, Sir Keith Holyoake, the Governor-General of New Zealand, hereby revoke the Proclamation dated the 10th day of January 1957, declaring an area of land in the Hawera Acclimatisation District, to be a Wildlife Refuge for the purposes of the Wildlife Act 1953, in so far as it affects the land described in the Schedule hereto.

Amending a Proclamation Defining the Middle Line of a Portion of the Ngauranga-Basin Reserve Motorway in the City of Wellington

A PROCLAMATION

PURSUANT to section 4 of the Public Works Amendment Act 1947, I, the Right Honourable Sir Keith Jacka Holyoake, the Governor-General of New Zealand, hereby amend the proclamation dated the 15th day of March 1966, published *Gazette* 24 March 1966, Volume I, p. 403, and registered as proclamation No. 666674 (Wellington Land Registry), (hereinafter called "the former Proclamation"), defining the middle line of a portion of the Ngauranga-Basin Reserve Motorway in the City of Wellington, so that the former proclamation shall affect not only the land situated within the limits shown coloured red on the plan marked M.O.W. 20212, referred to in the former proclamation, but also the pieces of streets described in the Schedule hereto.
