1. This notice may be cited as the Traffic (Paparua County) Notice No. 5, 1978.

2. The roads specified in the First Schedule hereto are hereby declared to be closely populated localities pursuant to section 52 of the Transport Act 1962.

3. The roads specified in the second Schedule hereto are hereby declared to be 70 kilometres an hour speed limit areas pursuant to regulation 21 (2) of the Traffic Regulations 1976*

4. So much of the notice under section 52 of the Transport Act 1962, and regulation 27 of the Traffic Regulations 1956, dated the 22nd day of January 1974†, which relates to roads situated within Paparua County at Avonhead, is hereby revoked.

5. The Traffic (Paparua County) Notice No. 1, 1975, dated the 25th day of June 1975‡, issued pursuant to section 52 of the Transport Act 1962, and regulation 27 of the Traffic Regulations 1956, which relates to roads situated within Paparua County, is hereby revoked.

FIRST SCHEDULE
