

18. To prohibit the lighting of fires on the said land except under such circumstances and subject to such limitations, conditions, and restrictions as may be prescribed by the grantee.

19. Generally to require the doing on or in respect of the said land of any act or thing which may be likely to prevent or mitigate soil erosion or promote soil conservation or the control of floods, and to prohibit the doing on or in respect of the said land of any act or thing which may be likely to facilitate soil erosion or floods.
