A PROCLAMATION

PURSUANT to section 14 of the Wildlife Act 1953, I, Sir Keith Jacka Holyoake, the Governor-General of New Zealand, hereby revoke the Proclamation dated the 19th day of July 1962\*, declaring an area of land in the Ashburton Acclimatisation District, Canterbury Land District, to be a Wildlife Refuge, for the purposes of the Wildlife Act 1953, in so far as it affects the land described in the Schedule hereto.
