

Notice of Final Decision of New Zealand Geographic Board re Assigning of Place Names

WHEREAS, pursuant to section 12 of the New Zealand Geographic Board Act 1946, notice was given on the 6th day of March 1978 of the intention of the New Zealand Geographic Board to assign the names set out in the Schedule attached to the said notice; and whereas, pursuant to section 13 of the said Act, no objections have been received to such of the proposed names as are set out in the First Schedule hereto:

Now, therefore, pursuant to sections 14 and 15 of the said Act, notice is hereby given that the names set out in the First Schedule hereto are final decisions of the Board and that such decisions take effect on the 20th day of September 1978.

Beeman Point	For coastal point below and south of Beeman Hill.
Borchgrevink Bay	For bay on northern coast.
Camp Stream	For stream flowing into Perservance Harbour.
Capstan Cove	For small bay in Northwest Bay. Not "Windless Bay".
Cattle Bay	For bay in Yvon Villarceau area.
Cave stream	For stream flowing into western end of Rocky Bay.
Cockayne Stream	For stream flowing into "Six Foot Lake" from southern slopes of Mount Honey.
Complex Point	For point at western headland of Northwest Bay.
Cook Point	For point on eastern coast at south seaward end of Northeast Harbour.
Courrejolles Point	Clarification of known point, not "peninsula".
Denver Peak	For highest point at landward end of Courrejolles Point
Depot Peak	For point between Camp Cove and Tucker Cove.
De la Vire Point	Instead of "Point de la Vire".
Dumas Stream	For stream flowing easterly from Mount Dumas into Garden Stream.
Duris Point	Instead of "Durns Point".
Garden Stream	For stream flowing into Perseverance Harbour at Garden Cove.
Gomez Island	For island off the west coast opposite Mount Azimuth.
Hasselburg Stream	For stream flowing south into Perseverance Harbour between Davis and Erebus Points.
Honey Falls	For waterfalls on Honey Stream.
Hook Keys	For group of islets off the western coast.
Isle de Jeanette Marie	For islet north-west of "Courrejolles Point". Instead of "Courrejolles Island".
Limestone Point	For point in Northwest Bay immediately east of "Capstan Cove".
Lookout Bay	For bay in Perseverance Harbour just east of Beeman Hill.
Long Falls	For waterfall on Smoothwater Stream.
Middle Bay	For small bay in Northwest Bay between Sandy Beach and Capstan Cove.
Macdonald Point	For point at eastern coast between East Cape and Cook Point.
Mollymawk Stream	For stream located between North Cape and Buchanan Stream.
Northeast Stream	For stream flowing into Northeast Harbour.
Norton Stream	For stream flowing into western part of Northwest Bay.
North Tarn	For tarn located east of "Twin Falls Stream".
Penguin Point	For bay on north-west coast just north of Yvon Villarceau Peak.
Ramp Point	For limestone ramp between Cattle Creek and Penguin Bay.
Shag Point	For point on south-east coast between Perseverance Harbour and Southeast Harbour.
Shag Stream	For stream flowing south-easterly towards coast at Shag Point.
Six Foot Lake	For lake just north of Monument Harbour.
Skua Basin	For basin just south-east of Mount Paris and facing the western end of Rocky Bay.
Smoothwater Stream	For stream flowing into Smoothwater Bay.
Sorensen Tarn	For tarn between North Cape and Mollymawk Stream.
Southeast Stream	For stream flowing into Southeast Harbour from Mount Honey.
Switchback Ridge	For ridge between Courrejolles Point and Mount Azimuth.
The Lion	Descriptive name for rock feature above and south of Venus Cove.
Tucker Stream	For stream flowing into Perseverance Harbour at Tucker Cove.
Twin Falls Stream	For stream on northern coast east of Hooker Stream.
Whalers Stream	For stream flowing into Capstan Cove.
Albatross Tarns	For group of tarns on north side of Southeast Harbour.
