

*Plants Declared Noxious Weeds in the County of Wanganui

DZ 7603 Polyethylene refuse sacks.

This draft covers polyethylene sacks issued by local bodies for the collection of both domestic and commercial refuse. It provides a material specification, lays down testing procedures to be used during manufacture of the sacks, and permits the use of recycled polyethylene (as requested by the Department of Trade and Industry).
