## FIRST SCHEDULE

## CANTERBURY LAND DISTRICT

*Description of Power Line Easement*

THE full and free right, liberty, licence and authority in perpetuity of Her Majesty the Queen to construct, equip, maintain, renew, repair, operate and patrol transmission lines thereon for the transmission of power and energy; which lines may consist of and include any tower, pylon, gantry, pole, support, insulator, casing, tube, maintenance telephone wire, line, cable or other conductor used or intended to be used for the transmission and distribution of electric power and energy and the support, maintenance, protection or insulation of any such transmission lines as may seem necessary or desirable, and for the aforesaid purposes, servants, workmen and agents of Her Majesty the Queen may from time to time, and at all times, enter by the most expedient route upon the said described land or any part thereof, with or without any suitable means of conveyance and with all such tools, machinery, articles and materials as may be necessary, desirable or proper for the doing of anything hereby authorised, and to make and construct all such works as may be necessary and proper for such purposes, and to remove such transmission lines or any part thereof and from time to time to deposit and store on the said described land tools, machinery, equipment and materials of any kind to be used in the construction or repairing of such transmission lines but only for so long a period as such work is actually in progress and to remove or carry away the same or any part thereof during or upon completion of the said work.
