The above hours of trading shall apply during the period from the 1st day of April to the 30th day of November (both days inclusive) in every year and the following hours of trading shall apply during the period from the 1st day of December to the 31st day of March (both days inclusive) in

(c) On any Monday, Tuesday, Wednesday, Thursday, Friday, and Saturday (not being Christmas Eve or New Year's Eve)—Opening at 11 o'clock in the morning and closing at 10 o'clock in the evening.
 (d) On any Christmas Eve—Opening at 11 o'clock in the

(e) On New Year's Eve—Opening at 11 o'clock in the evening.

(e) On New Year's Eve—Opening at 11 o'clock in the morning and closing at 00.30 o'clock in the morning of New Year's day.

It shall be a condition that a substantial meal be available from 9 o'clock in the evening on each evening when the premises are open for more than the usual 11 hours in any
