*Revoking a Proclamation Declaring an Area in the Southland  
Acclimatisation District to be a Wildlife Refuge*

A PROCLAMATION

PURSUANT to section 14 of the Wildlife Act 1953, I, The Right Honourable Sir Keith Jacka Holyoake, the Governor-General of New Zealand, hereby revoke the Proclamation issued on the 19th day of May 1960\* declaring an area in the Southland Acclimatisation District to be a wildlife refuge for the purposes of the Wildlife Act 1953.

## SCHEDULE

SECTIONS 29, 30, 31 and 32, Block II, Aparima Hundred: area, 253 acres 3 roods 12 perches, more or less.

All certificate of title, Volume 115, folio 81. The north-west corner of Section 32 is at National Grid Reference 065, 383, grid square S.22.

A PROCLAMATION

PURSUANT to the Public Works Act 1928, I, The Right Honourable Sir Keith Jacka Holyoake, the Governor-General of New Zealand, hereby revoke the Proclamation dated the

27th day of October 1976 and published in *New Zealand Gazette*, No. 113, 4 November 1976, at p. 2489, and deposited in the Land Registry Office at Dunedin as No. 468825, taking land for works, appliances and conveniences necessary, directly or indirectly, for the generation of electricity in the Borough of Cromwell and the County of Vincent, in so far as it affects the land described in the Schedule hereto.

### OTAGO LAND DISTRICT

ALL that piece of land situated in the Town of Cromwell, containing 4048 square metres, being Sections 2, 3, 4 and 5, Block LXXVI. Part certificate of title, 5B/652.
