

Survey District and proceeding westerly along the northern boundary of Block II, aforesaid to the middle of the Waikaka Stream; thence generally southerly down the middle of that stream to a point in line with the northern boundary of Lot 4, D.P. 2080; thence westerly by a right line to and along that boundary and its production across Willowbank Waikaka Road, to the north-eastern corner of Lot 2, D.P. 2080 and continuing westerly along the northern boundaries of Lot 2, D.P. 2080, Section 52, Block I, Chatton Survey District and Lot 1, D.P. 2080 to the eastern boundary of Section 26, aforesaid; thence southerly along the eastern boundary of Section 26, aforesaid, and by a right line across the intersecting Pryde Road and again along the eastern boundary of Section 26 to the northern boundary of part Section 19 aforesaid; thence westerly and southerly along the northern and western boundaries of that Section to the south-eastern corner of Section 18 aforesaid; thence westerly along the southern boundary of Section 18, aforesaid, and its production to the middle of Chittock Road; thence northerly along the middle of that road to a point in line with the southern boundary of Section 32, aforesaid; thence by a right line to and along that boundary to the western boundary of Block I, Chatton Survey District; thence northerly along that boundary to the south-eastern corner of Section 7, Block X, Chatton Survey District; thence westerly along the southern boundary of Sections 7, 8, 9, and 15 to the western boundary of Block X, Chatton Survey District; thence northerly along the western boundaries of Blocks X, V, and IV, Chatton Survey District, to the south-eastern corner of Section 11, Block VIII, Wendon Survey District; thence northerly along the eastern boundary of Section 11, aforesaid, to the south-eastern side of Blackhills Road; thence north-westerly by a right line across Blackhills Road to the south-eastern corner of Section 8, aforesaid; thence northerly along the eastern boundary of Section 8, aforesaid to the generally western side of Blackhills Road; thence generally northerly along the generally western side of that road to the eastern boundary of Section 16, Block VIII, Wendon Survey District; thence northerly along the eastern boundary of that section to Kee Road; thence by a right line across Kee Road to the south-eastern corner of Section 17, aforesaid; thence northerly along the eastern boundary of the last-mentioned section to Kennedy Road; thence by a right line across Kennedy Road to the south-eastern corner of Section 18, Block VIII, Wendon Survey; thence northerly along the eastern boundary of that section to the northern boundary of Block VIII, Wendon Survey District; thence easterly along the northern boundaries of Blocks VIII and IX, Wendon Survey District and Block XI, Greenvale Survey District, to the easternmost corner of Section 22, Block XII, Greenvale Survey District; thence generally northerly along the eastern boundary of the last-mentioned section and its production to the western side of Leithen Road; thence generally north-easterly along that roadside to a point in line with the north-eastern boundary of part Lot 2, D.P. 1142; thence south-easterly to and along that boundary and its production to the south-eastern side of Mocking Bird Hill Road; again generally south-easterly along the north-eastern boundaries of Lot 4 and part Lot 5, D.P. 1142 to the north-eastern corner of the last-mentioned part Lot; thence south-easterly along the north-eastern boundary of that part Lot 5 to the westernmost corner of Lot 6, D.P. 1142; thence generally easterly along the northern boundary of the last-mentioned lot and its production to the eastern side of Terrace Farm Road; thence southerly along that roadside and its production to the north-eastern corner of D.P. 3581; thence southerly along the eastern boundaries of the land shown on D.P. 3581, part Lot 5 (173.6404 hectares), D.P. 1135 and the production of the last-mentioned boundary to the north-eastern corner of part Lot 5 (248.3849 hectares), D.P. 1135; again southerly then westerly along the eastern and southern boundaries of the last-mentioned part Lot 5 to the north-western corner of Section 27, Block II, Glenkenich Survey District; thence southerly along the western boundary of that section and its production to the southern side of Fleming Road; thence generally southerly along the western boundary of Section 28, Block II, Glenkenich Survey District to its intersection with Cleghorn Road; again generally southerly along the eastern side of that Road to the south-western corner of Section 3, Block II, Glenkenich Survey District; thence westerly to and along the southern boundary of Section 2, Block II, Glenkenich Survey District to its westernmost corner; thence south-easterly and westerly along the north-eastern and southern boundaries of part Section 23, Block V, Glenkenich Survey District to the north-eastern corner of Section 21, Block V, Glenkenich Survey District; thence southerly along the eastern boundary of that section and its production to the southern side of Brock Road; thence

north-westerly along that roadside to the north-eastern corner of Section 19, Block V, Glenkenich Survey District; thence southerly along the eastern boundary of that section to its south-eastern corner; thence westerly along the southern boundaries of that Section 19 and Sections 18 and 17, Block V, Glenkenich Survey District to the north-western corner of Section 8, Block V, Glenkenich Survey District; thence southerly along the western boundary of the last-mentioned section and its production to the southern side of Maitland-Waikoikoi Road; again southerly along the western boundary of Section 6, Block V, Glenkenich Survey District to the southern boundary of the last-mentioned Block; thence westerly along that block boundary to the south-western corner of part Section 28, Block V, Glenkenich Survey District; thence by a right line across Donald Road to the eastern corner of Lot 1, D.P. 9049 being the point of commencement.

Riversdale Fire District Notice 1979

PURSUANT to section 26 of the Fire Service Act 1975, the New Zealand Fire Service Commission hereby gives the following notice.

NOTICE

1. Title and commencement:

- (1) This notice may be cited as the Riversdale Fire District Notice 1979.
- (2) This notice shall come into effect on the 1st day of December 1979.

2. The Riversdale Fire District, declared to be a fire district by the Fire Service Act 1975, is hereby abolished, and a fire district to be known as the Riversdale Fire District is hereby constituted.

3. The boundaries of the Riversdale Fire District constituted by this notice are defined in the Schedule hereto.

SCHEDULE

ALL that area in the Southland Land District, County of Southland, bounded by a line commencing at the north-western corner of Block V, Wendonside Survey District, and proceeding southerly along the western boundary of Block V, aforesaid to a point in line with the southern boundary of Section 7, Block V, Wendonside Survey District; thence westerly along the production of that boundary to the middle of the Mataura River; thence southerly along the middle of the Mataura River to the intersection with the middle of a channel forming the southern boundary of part Section 540, Block XVII, Hokonui Survey District; thence westerly along the middle of the aforesaid channel to a point in line with the north-western boundary of Lot 8, D.P. 915, Block XVII, Hokonui Survey District; thence south-westerly by a right line to and along that boundary to the south-westernmost corner of Lot 8, D.P. 915 aforesaid; thence south-westerly by a right line, across the Ardlussa Riverdale Road, to the northernmost corner of part Lot 3, D.P. 915, Block XXIII, Hokonui Survey District; thence generally southerly along the generally western boundaries of Block XXIII and XXX, Hokonui Survey District to the southernmost corner of Lot 4, D.P. 426, Blocks XXII and XXX, Hokonui Survey District; thence southerly by a right line, across the Mandeville Kingston Crossing Road, to the easternmost corner of Lot 1, D.P. 1344, Block XXII, Hokonui Survey District; thence north-westerly and south-westerly along the north-eastern and north-western boundaries of Lot 1, D.P. 1344 aforesaid and the last-mentioned boundary produced to the middle of Longridge Village Road; thence north-westerly along the middle of the Longridge Village Road to a point in line with the south-eastern boundary of Lot 1, D.P. 6006, Block XXII, Hokonui Survey District; thence south-westerly by a right line, to and along that boundary to the south-easternmost corner of Lot 1, D.P. 6006 aforesaid; thence north-westerly along the south-western boundary of Lot 1, D.P. 6006 aforesaid to the northernmost point of part Section 51, D.P. 308, Block XXIX, Hokonui Survey District; thence south-westerly and south-easterly along the north-western and south-western boundaries of part Section 51, aforesaid to a point in line with the north-western boundary of part Lot 22, D.P. 379, Block XXIX, Hokonui Survey District; thence south-westerly
