Lumsden Fire District Notice 1979

PURSUANT to section 26 of the Fire Service Act 1975, the New Zealand Fire Service Commission hereby gives the following notice.

NOTICE

1. Title and commencement:
(1) This notice may be cited as the Lumsden Fire District Notice 1979.
(2) This notice shall come into effect on the 1st day of December 1979.
2. The Lumsden Fire District, declared to be a fire district by the Fire Service Act 1975, is hereby abolished, and a fire district to be known as the Lumsden Fire District is hereby constituted.
3. The boundaries of the Lumsden Fire District constituted by this notice are defined in the Schedule hereto.

SCHEDULE

ALL that area in the Southland Land District and the Counties of Southland and Wallace, bounded by a line commencing at the westernmost corner of Block XI, Taringatura Survey District; and proceeding generally north-easterly along the generally north-western boundary of the said Block XI, to the northernmost corner of Lot 58, D.P. 650, Block XI, Taringatura Survey District; thence northerly by a right line across the intersection of Cumming and Honeywood Roads to the southernmost corner of Lot 52, D.P. 644, Block XI, Taringatura Survey District; thence north-westerly along the south-western boundary of the said Lot 52 to a point in line with the south-westernmost boundary of Block VI, Taringatura Survey District; thence south-westerly by a right line to the southernmost corner of said Block VI, thence generally north along the generally east boundaries
