

The Misuse of Drugs Act 1975—Notice of Authorisation

NOTICE is hereby given that the Minister of Health, acting under section 19 (1) of the Misuse of Drugs Act 1975, has authorised the Public Health Pharmacist named in the Schedule hereto to enter the premises of any person who carries on the business of a producer, manufacturer, seller, or distributor of any controlled drug, or who otherwise undertakes the supply or administration of any controlled drug, and to demand the production of, and to inspect any, books or documents relating to dealings in any controlled drug, and to inspect, weigh, measure, and record the stocks of controlled drugs.

Balfour Fire District Notice 1979

PURSUANT to section 26 of the Fire Service Act 1975, the New Zealand Fire Service Commission hereby gives the following notice.

NOTICE

1. Title and commencement:

- (1) This notice may be cited as the Balfour Fire District Notice 1979.
- (2) This notice shall come into effect on the 1st day of December 1979.

2. The Balfour Fire District, declared to be a fire district by the Fire Service Act 1975, is hereby abolished, and a fire district to be known as the Balfour Fire District is hereby constituted.

3. The boundaries of the Balfour Fire District constituted by this notice are defined in the Schedule hereto.

SCHEDULE

ALL that area in the Southland Land District, County of Southland bounded by a line commencing in the middle of the Mataura River at the north-eastern corner of Block XI, Hokonui Survey District; thence south-easterly along the middle of the Mataura River to the intersection with the middle of a channel forming the southern boundary of part Section 540, Block XVII, Hokonui Survey District, thence westerly along the middle of the said channel to a point in line with the north-western boundary of Lot 8, D.P. 915, Block XVII, Hokonui Survey District; thence south-westerly by a right line to and along that boundary to the south-westernmost corner of the said Lot 8; thence southerly by a right line across the Ardlussa Riversdale Road to the northernmost corner of part Lot 3, D.P. 915, Block XXIII, Hokonui Survey District; thence generally southerly along the generally westerly boundaries of Block XXIII and XXX, Hokonui Survey District to the southernmost corner of Lot 4, D.P. 426, Block XXII and XXIII, Hokonui Survey District; thence southerly by a right line across the Mandeville Kingston Crossing Road to the easternmost corner of Lot 1, D.P. 1344, Block XXII, Hokonui Survey District; thence north-westerly and south-westerly along the north-eastern and south-western boundaries of the said Lot 1 and the production of the last-mentioned boundary to the middle of Longridge Village Road thence north-westerly along the

middle of the said road to a point in line with the south-eastern boundary of Lot 1, D.P. 6006, Block XXII, Hokonui Survey District; thence south-westerly by a right line to and along that boundary to the south-eastern corner of the said Lot 1; thence north-easterly along the south-western boundary of the said Lot 1 to the northernmost corner of part Section 51, D.P. 308, Block XXIX, Hokonui Survey District; thence south-westerly and south-easterly along the north-western and south-western boundaries of the said part Section 51 to a point in line with the north-western boundary of part Lot 22, D.P. 379, Block XXIX, Hokonui Survey District; thence south-westerly by a right line, across McAlister Road, to and along that boundary to the westernmost corner of the said part Lot 22; thence south-easterly along the south-western boundary of the said part Lot 22, to the easternmost corner of Section 962, Block XXIX, Hokonui Survey District; thence south-westerly and north-westerly along the south-eastern and south-western boundaries of the said Section 962, to a point in line with the south-eastern boundary of Lot 1, D.P. 9160, Block XXXVIII, Hokonui Survey District; thence south-westerly by a right line, across Blue Road, to and along that boundary and the production of that boundary to the middle of the Waimea stream; thence north-westerly along the middle of the present position of the Waimea stream to a point in line with the south-eastern boundary of Lot 12, D.P. 419, Block XX, Hokonui Survey District; thence south-westerly by a right line to and along that boundary to the intersection with the south-western boundary of Block XX, Hokonui Survey District; thence generally north-westerly and northerly along the generally south-western boundaries of Block XX and XIII and the generally western boundaries of Block XIII and IX, Hokonui Survey District to the intersection with the northern boundary of Lot 5, D.P. 432, Block IX, Hokonui Survey District; thence easterly along the northern boundaries of the said Lot 5, Lots 6, 7, and part Lot 8 the said D.P. 432 and the production of the last-mentioned boundary across State Highway No. 94 and the Waimea Plains Branch Railway to a point on the south-western boundary of Lot 4, the said D.P. 432; thence south-easterly and north-easterly along the south-western and south-eastern boundaries of the said Lot 4, D.P. 432, to the northernmost point of Lot 10, the said D.P. 432; thence south-easterly along the north-eastern boundary of the said Lot 10, D.P. 432 to the southernmost corner of Lot 18, D.P. 94, Block IX, Hokonui Survey District; thence north-easterly along the south-eastern boundary of the said Lot 18 and the production of that boundary across the Old Balfour Road to the southernmost corner of Lot 13, the said D.P. 94; thence north-easterly along the south-eastern boundary of the said Lot 13 and the production of that boundary to the middle of Clarke Road; thence north-westerly along the middle of Clarke Road to a point in line with the south-eastern boundary of Section 77, Block X, Hokonui Survey District; thence north-easterly by a right line to and along that boundary to the easternmost corner of the said Section 77, thence north-westerly along the north-eastern boundary of the said section 77 to the westernmost corner of Section 582, Block X, Hokonui Survey District; thence generally easterly along the generally northern boundaries of Blocks X and XI, Hokonui Survey District to the point of commencement.
