A PROCLAMATION

PURSUANT to subsection (6) of section 5 of the Education Lands Act 1949, I, Sir Keith Jacka Holyoake, the Governor-General of New Zealand, hereby proclaim and declare that the land described in the Schedule hereto, being an area vested in the Auckland Education Board as a site for a school, shall be vested in Her Majesty the Queen, freed and discharged from every education trust affecting the same, but subject to all leases, encumbrances, liens, or easements affecting the same at the date hereof.

NORTH AUCKLAND LAND DISTRICT—PAPAKURA CITY

1.5681 hectares, more or less, being Lot 205, Section 11, Papakura Village, situated in Block IV, Drury Survey District. Part *New Zealand Gazette*, 1918, p. 3880, S.O. Plan 1356C.
