address of each member. The circular shall contain a copy of the proposed alteration, amendment, or repeal, but the accidental omission to give any such notice to any member shall not invalidate any proceedings taken or any resolution passed at any such meeting. No amendment which introduces fresh matter shall be entertained at the meeting and no proposed amendment, or repeal of, or addition to, the rules, if rejected, shall be entertained again for 12 months.

proposed amendment, or repeat or, or addition to, the rules, if rejected, shall be entertained again for 12 months. Any proposed alteration, amendment, or repeal of these rules must be passed by a three-quarters majority of those members present and voting.

### Dissolution

77. The distribution of the property of the Exchange in the event of its winding up shall be determined by a special general meeting of the members of the Exchange.
