PURSUANT to sections 21 (6), 25 (4), 25 (5), and 29 of the Animal Remedies Act 1967, the Registrar of Animal Remedies hereby gives notice that licences have been issued, renewed, have lapsed, or have been varied as set out in the Schedules hereto;
