Proclaiming Areas in the City of Napier to be Reclamation Areas under Part II of the Urban Renewal and Housing Improvement Act 1945

A PROCLAMATION

PURSUANT to section 19 of the Urban Renewal and Housing Improvement Act 1945, I, Sir Keith Jacka Holyoake, the Governor-General of New Zealand, hereby proclaim the parcels of land defined in the Schedule hereto to be reclamation areas under Part II of the said Act; and I also declare that this Proclamation shall take effect on and after the 24th day of February 1979.

SCHEDULE

ALL those areas of land situated within City of Napier:

First, at number 6A Nelson Crescent, being more particularly the land described below, containing a total area of two thousand five hundred and seventy-eight square metres (2578 m²) or thereabouts, being Lots 5 and 6 on Deposited Plan 3804, and being all the land comprised and described in certificate of title (H.B. Registry), Volume G3, folio 1173; and Second, on the southern side of Wellesley Road, being

more particularly the land described below, containing a total area of six thousand four hundred and nine square metres (6409 m²) or thereabouts being:

Lots 32 and 34 on Deposited Plan 2172, Lots 1 and 2 on Deposited Plan 6251, Lots 1, 2, 3 and part Lot 4 on Deposited Plan 4097, being all the land comprised and described in certificates of title (H.B.
