

FIFTH SCHEDULE
ROTOITI WARD

ALL that area in the South Auckland Land District bounded by a line commencing at the intersection in Block II, Rotoiti Survey District, of the eastern side of Kapukapu Road with the southern boundary of Part Section 1, Block XIV, Maketu Survey District; proceeding easterly along the southern boundary of the said part Section 1, and its production to the middle of the Kaituna River; thence southerly up the middle of that river to a point in line with the north-eastern boundary of part Okere 1E; thence south-easterly to and along that boundary and its production to the middle of No. 33 State Highway; thence, generally, southerly along the middle of that State Highway to a point in line with the northern boundary of part Waipapa 1D; thence to and along that boundary and its production to the middle of the Pokopoko Stream; thence southerly up the middle of that stream to a point in line with the northern boundary of part Rotoiti 3V; thence to and along that boundary, the northern end of Lichensteins Road, the northern boundaries of Rotoiti 3V 2A and Tokerau A. 1B to and along a right line across Maniatutu Road to and along the northern boundaries of Tokerau A2 and A4, crossing Kaikokopu Road, and along the northern boundaries of Rotoiti 5B 1 and 5B 2 to the middle of the Pongakawa Stream; thence northerly down the middle of that stream to a point in line with the northern boundary of Section 2, Block I, Rotoma Survey District; thence to and along that boundary and its production to the middle of Pongakawa Valley Road; thence, generally, south-easterly along the middle of that road to a point in line with the southern boundary of Section 10, Block VI, Rotoma Survey District; thence to and along that boundary and the southern boundary of Section 2, Block VII, Rotoma Survey District, and its production to the eastern side of Lake Rotoma Road; thence, generally, south-easterly along the generally northern boundary of Section 12, Block VII, aforesaid, to a right line between the south-eastern corner of part Section 6, Block VI, Waihi South Survey District, and the north-western corner of part Section 15, Block XI, Rotoma Survey District; thence southerly along that right line to and along the western boundaries of part Section 15, aforesaid, and part Allotment 63, Matata Parish, to the southernmost corner of that Allotment; thence south-westerly along a right line to Trig. Station 18, Maungawhakamana, in Block III, Ruawahia Survey District; thence southerly along a right line between Trig. Station 18 and Trig. Station 38, Ahiwhakamura, in Block X, Kaingaroa Survey District, to the middle of the Tarawera River in Block III, Ruawahia Survey District; thence, generally, westerly up the middle of the said river to and along the northern shores of Lake Tarawera, to the southern corner of Rotomahana Parekarangi 6B; thence north-westerly along the north-eastern boundary of that Block to its northern corner; thence south-westerly along the south-eastern boundary of Okataina 10 in Block III, Tarawera Survey District, to and north-westerly along the south-western boundaries of Part Okataina 6B, the said Okataina 10 and Okataina 12, and the western boundaries of the last-named block to the southern corner of Whakapoungakau 16 Section 2B2G1 as shown on M.L. 14146; thence north-westerly along the south-western boundary of that block and along a right line across State Highway 30 to and along the south-western boundaries of Parts Whakapoungakau 16 Section 2B2F to the shore of Lake Rotorua in Block XIV, Rotoiti Survey District; thence, generally, south-westerly, northerly, and easterly along the southern, western, and northern shores of that lake, to a point in line with the eastern boundary of Section 28, Block V, Rotoiti Survey District; thence northerly across Okere Hamurana Road to and along that boundary and the eastern boundary of Section 39 of the said Block V to the southern side of Hoka Road; thence, generally, westerly along that side to a point in line with the eastern boundary of Section 5, Block V, Rotoiti Survey District; thence northerly to and along that boundary to the southern boundary of Lot 2, D.P. S. 20232; thence easterly along that boundary and the southern boundary of Part Section 6 of the said Block V; thence northerly along the eastern boundary of the said Part Section 6 to the south-eastern side of Kaharoa Road; thence north-westerly along a right line across that Road to and along the north-eastern boundaries of Part Section 8 and Section 7, Block I, Rotoiti Survey District to the south-eastern side of Kapukapu Road; thence, generally, north-easterly along that side to the point of commencement.

SIXTH SCHEDULE
ROTOMAHANA WARD

ALL that area in the South Auckland Land District bounded by a line commencing at the intersection in Block III, Ruawahia Survey District, of the middle of the Tarawera River

with a right line between Trig. Station 18, Maungawhakamana in Block III, Ruawahia Survey District, and Trig. Station 38, Ahiwhakamura, in Block X, Kaingaroa Survey District, and proceeding southerly along that right line and its production to another right line between Trig. Station 2120, Tawhiuau, in Block XIV, Galatea Survey District, and Trig. Station 31, Paeroa, in Block V, Paeroa Survey District; thence north-westerly along the last-mentioned right line to the middle of State Highway 38; thence, generally, north-westerly along that middle to and along the middle of closed road as shown on S.O. 43263 to a point in line with the southern boundary of Part Pakaraka A9 in Block III, Paeroa Survey District; thence westerly to and along that boundary, crossing State Highway 5, and the production of the said boundary across Section 43, Block II, Paeroa Survey District, to Trig. 30, Maungaongaonga; thence north-westerly to and along the south-western boundary of Part Rotomahana Parekarangi 6A2 Section 1A to and north-easterly along the north-western boundary of that block to the southern boundary of Part Pakaraka A8; thence westerly and northerly along the southern and western boundaries of that block, crossing a roadway, to the north-eastern corner of Part Rotomahana Parekarangi 6A2 Section 3B1A2; thence south-westerly along the south-eastern boundary of that Block to a point in line with the south-western boundary of the said 6A2 Section 3B1A2 as shown on M.L. 17600; thence north-westerly to and along that boundary, the south-western boundaries of Part Pakaraka A8, aforesaid, and Pakaraka A7, as shown on M.L. 18390 and the south-western boundary of Te Peka Block as shown on M.L. 14126 to the northern boundary of Block IX, Tarawera Survey District; thence westerly along that boundary to the middle of State Highway 5; thence, generally, northerly along that middle to a right line between the northern corner of Part Rotomahana Parekarangi 6S2B situated in Block V, Tarawera Survey District, and a point in the middle of Tarawera Road in line with the north-western boundary of Part Rotomahana Parekarangi 4A in Block II, Tarawera Survey District; thence north-easterly along the said right line to and south-easterly along the middle of Tarawera Road, aforesaid, to a point in line with the north-western boundary of Lot 2, D.P. S. 3313; thence north-easterly to and along that boundary and the north-western boundary of Lot 1, D.P. S. 3313, to and south-easterly along the north-eastern boundary of that lot to the north-western corner of Section 22, Block III, Tarawera Survey District; thence north-easterly along the north-western boundaries of that section and Section 16 of the said Block III to the northernmost corner of the last-named section; thence south-westerly along the south-western boundaries of Okataina 12, Okataina 10, Part Okataina 6B, to and north-easterly along the south-eastern boundary of the said Okataina 10 to the north-eastern corner of Rotomahana Parekarangi 6B; thence south-easterly along the north-eastern boundary of that block to the northern shore of Lake Tarawera; thence, generally, easterly along that shore to and down the middle of the Tarawera River to the point of commencement.

SEVENTH SCHEDULE
REPOROA WARD

ALL that area in the South Auckland Land District bounded by a line commencing at a point in the middle of the Waikato River in line with the south-eastern boundary of Part Section 2, Block X, Ngongotaha Survey District, and proceeding north-easterly to and along the south-eastern boundary of Part Section 2, aforesaid, a right line across a closed road to and along the south-eastern boundaries of Part Section 2, Block VIII, Ngongotaha Survey District, and Rotomahana Parekarangi 6A2 Section 2B1 to Trig. 31, Paeroa; thence again north-easterly along a right line to Trig. 30, Maungaongaonga, and a right line to and along the southern boundary of Part Pakaraka A9 and that boundary produced to the middle of closed road as shown on S.O. 43263; thence south-easterly along the said closed road to and along the middle of State Highway 38 to a right line between Trig. Station 2120, Tawhiuau, in Block XIV, Galatea Survey District, and Trig. Station 31, Paeroa, in Block V, Paeroa Survey District; thence north-westerly along that right line to the eastern boundary of Section 20, Block XI, Paeroa Survey District; thence southerly along that boundary and the south-eastern boundary of Section 29, Block XV, Paeroa Survey District, to the south-eastern corner of Section 29; thence easterly along the northern boundaries of Sections 7 and 8, Block XV, aforesaid, to the north-western corner of the land shown in D.P. 20113; thence southerly along the western boundary of that land to the south-western boundary of Paeroa East 3A, as shown on M.L. 4440; thence north-westerly along that boundary to the easternmost corner of Lot 1, D.P. 30839; thence south-westerly along the south-eastern boundary of that lot to and along the north-western boundaries of part Run 59
