The Traffic (Manukau City-Mangere/Otara Wards) Notice No. 1, 1979

PURSUANT to the Transport Act 1962, the Minister of Transport hereby gives the following notice:

NOTICE

1. This notice may be cited as the Traffic (Manukau City-Mangere/Otara Wards) Notice No. 1, 1979.

2. The roads specified in the First Schedule hereto are hereby excluded from the limitation as to speed imposed by section 52 of the Transport Act 1962.

3. The roads specified in the Second Schedule hereto are hereby declared to be 70 kilometres an hour speed limit areas pursuant to regulation 21 (2) of the Traffic Regulations 1976*.

4. The Traffic (Manukau City-Mangere/Otara Wards) Notice 1977, dated the 25th day of August 1977†, under section 52 of the Transport Act 1962, and regulation 21 of the Traffic Regulations 1976, which relates to roads situated within the Mangere and Otara Wards of Manukau City, is hereby revoked.
