PURSUANT to section 165 of the Harbours Act 1950, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. (a) This order may be cited as the Auckland Harbour Board (Westhaven) Foreshore and Harbour Bed Control

Order 1979.

(b) This order shall come into force on the date of its publication in the Gazette.

2. In this order-

"The Act" means the Harbours Act 1950;
"The Board" means the Auckland Harbour Board;
"Foreshore" means such part of the bed, shore, or banks

of a tidal water as are covered and uncovered by the flow and ebb of the tide at ordinary spring tide; "Minister" means the Minister of Transport, and includes any officer, person, or authority acting by or under the direction or authority of the Minister.

3. There is hereby granted to the board for a period of 21 years from the commencement of this order; subject to the provisions of section 165 of the Act, and to the conditions described in the Second Schedule to this order, control of the foreshore and harbour bed as described in the First Schedule to this order.
