

*The Road Classification (Rotorua District) Notice No. 1, 1979*

PURSUANT to regulation 3 of the Heavy Motor Vehicle Regulations 1974\*, the Secretary for Transport hereby gives the following notice:

## NOTICE

1. This notice may be cited as the Road Classification (Rotorua District) Notice No. 1, 1979.
