(a) A designated tyre section width of 13 inches and a

rim diameter of 24 inches or greater at the bead

(b) A designated tyre section width of 14 inches or greater and a rim diameter of 20 inches or greater at the bead seat,

and in either case having a tyre inflation not exceeding 414 kPa (60 pounds per sq. in.).
