

*Notice Declaring Burdock a Class B Noxious Plant*  
(No. 2249, Ag. 12/10/10)

1. Pursuant to section 19 of the Noxious Plants Act 1978, the Noxious Plants Council hereby declares burdock (*Arctium spp.*) to be a class B noxious plant in those parts of New Zealand lying within the boundaries of:

- (a) The Hastings Noxious Plants Regional Co-ordinating Committee;
- (b) The Hawera, Kiwitea and Waitotara District Noxious Plants Authorities;
- (c) The Kaikoura and Marlborough District Noxious Plants Authorities;
- (d) The Canterbury Noxious Plants Regional Co-ordinating Committee; and
- (e) The Bruce, Clutha, Lake, Maniototo, Waihemo, Waitaki, and Vincent District Noxious Plants Authorities.

2. This notice shall come into effect on the day after the date of notification in the *Gazette*.

- (f) The Southland and Wallace District Noxious Plants Authorities.

- (b) In that part of the Province of Canterbury lying north of the Rangitata River.
