

Notice of Intention to Vary Hours of Sale of Liquor at Licensed Premises—Waikato Licensing Committee

PURSUANT to section 221A of the Sale of Liquor Act 1962 as amended by section 22 (14) of the Sale of Liquor Amendment Act 1976, I, John Fraser Robertson, Secretary for Justice, hereby give notice that the Waikato Licensing Committee, on 5 October 1979, made an order authorising variations of the usual hours of trading for the licensed premises known as the Coroglen Tavern, Coroglen.

To the intent that on days other than those on which licensed premises are required to be closed for the sale of liquor to the general public the hours for the opening and closing of the said premises shall be as follows:

- (a) On any Monday, Tuesday, Wednesday, and Thursday (not being Christmas Eve or New Year's Eve)—Opening at 11 o'clock in the morning and closing at 10 o'clock in the evening.
- (b) On any Friday and Saturday from and including the Friday prior to each Labour Weekend and for a period of six months thereafter—Opening at 11 o'clock in the morning and closing at 11 o'clock in the evening.
- (c) On every Christmas Eve and New Year's Eve—Opening at 11 o'clock in the morning and closing at 11 o'clock in the evening.

Subject to adequate food provided up to closing time.

Revision of Orepuki Fire District Notice 1979

PURSUANT to section 26 of the Fire Service Act 1975, the New Zealand Fire Service Commission hereby gives the following notice.

NOTICE

1. Title and commencement:

- (1) This notice may be cited as the Orepuki Fire District Notice 1979.
- (2) This notice shall come into effect on the 1st day of December 1979.

2. The Orepuki Fire District, declared to be a fire district by the Fire Service Act 1975, is hereby abolished, and a fire district to be known as the Orepuki Fire District is hereby constituted.

3. The boundaries of the Orepuki Fire District constituted by this notice are defined in the Schedule hereto.

SCHEDULE

ALL that area in the Southland Land District, County of Wallace bounded by a line commencing at the south-western corner of Block VIII, Longwood Survey District, being a point on the sea coast; thence proceeding northerly generally along the generally western boundaries of Blocks VIII and VII, Longwood Survey District to the southernmost corner of Section 23, Block XII, Longwood Survey District; thence generally north-westerly along the generally north-eastern boundaries of Sections 23 and 22, Block XII, aforesaid to the northernmost corner of Section 22, Block XII, aforesaid and the production of the last-mentioned boundary to the middle of a public road forming the eastern boundary of Section 16, Block XII, aforesaid; thence generally northerly and westerly along the middle of the aforesaid road to a point in line with the eastern boundary of Section 32, Block XII, aforesaid; thence northerly by a right line to and along that boundary and the production of that boundary, across a public road, to the south-eastern corner of Section 33, Block XII, aforesaid; thence northerly and generally westerly along the eastern and generally northern boundaries of Section 33, aforesaid and the last-mentioned boundary produced to the middle of a public road forming the generally eastern and northern boundaries of Sections 34, 43, and 10, Block XII, aforesaid, and Sections 60 and 30, Block III, Longwood Survey District; thence generally northerly and westerly along the middle of the aforesaid road to a point in line with the eastern boundary of Section 24, Block III, Longwood Survey District; thence northerly by a right line to and along that boundary to the north-eastern corner of Section 24, aforesaid; thence westerly along the northern boundary of Section 24 aforesaid and that boundary produced to the middle of the Waimeamea River; thence south-westerly along the middle of the Waimeamea River to a point in line with the western boundary of Section 26, Block III, aforesaid; thence northerly by a right line to the south-western corner of Section 26, aforesaid; thence generally
