as an officer of the Government of the Dependency with effect from the commencement of the 8th day of October 1979 until the expiry of the 31st day of January 1980: And I also appoint

as an officer of the Government of the Dependency with effect from the commencement of the 1st day of February 1980 until the expiry of the 14th day of October 1980:
